

Report on Regional Public Health Services and Health Promotion Services 2008

【Digest of Summary Report】

- The actual number of “pregnant or parturient women” who had basic health examination by municipality: the number of “pregnant women” was about 1,380,000, and the number of “parturient women” was about 66,000.
- The total number of clients at the public health centers or mental health and welfare centers of municipality: “in-person counseling” about 768,000, “day-care services” about 209,000, “home-visiting guidance” about 333,000 and “telephone counseling” about 1,114,000.
- The number of clients who had hepatitis virus examination by municipality: The number of clients who had “hepatitis C virus examination” was about 692,000, and those who had “hepatitis B virus examination” was about 694,000.

Outline of Report on Regional Public Health Services and Health Promotion Services

1 Objective

Report on Regional Public Health Services and Health Promotion Services is to perceive the development of health care policy, etc. based on regional characteristics with a view to health management and improvement of local residents by public health center and municipality that implement the policy, thereby obtaining basic data for efficient and effective promotion of the regional health care policy by government and local public agencies.

Public health centers and municipalities nationwide

Yearly report

Services including maternal and child health

Liaison and coordination among public health centers and others

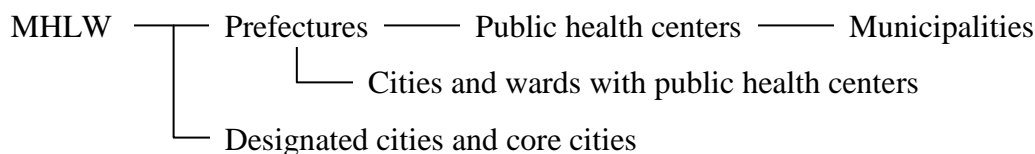
Assignment of public health center staff and their support to municipality

5 Method and Route

(1) The governor and head of prefectures, designated cities, and core cities report to the director-general of Statistics and Information Department, Minister's Secretariat, Ministry of Health, Labour and Welfare by the time due to each report item.

(2) The route of report is as follows



6 Report Period

Due date of report to national government: The end of June in the next year

7 Notes

(1) The responsible agencies for Report on Regional Public Health Services and Health Promotion Services (hereafter, the Reports) are "Public health centers" and "Municipalities" for Report on Regional Public Health Services and "Municipalities" for Report on Health Promotion Services.

(2) In the Reports, "Cabinet-order designated cities" means cities with public health centers, and "Special area" means Tokyo's 23 wards.

(3) The population used to calculate the rates “per 100,000 population” in this outline is the “Population based on the basic resident registration (as of 31 March 2009” by the Ministry of Internal Affairs and Communications.

(4) Symbols used in the tables
