Outline of Survey Results

1 Estimated Number of Patients (per day)

The estimated number of patients who received medical treatment nationwide on the dates of survey were 1,318.8 thousand "inpatients" and 7,238.4 thousand "outpatients".

(1) Estimated number of patients (per day) by type of medical care institution, sex and age group

Viewing the 1,318.8 thousand of the estimated number of "inpatients" by type of medical care institution, 1,273.0 thousand inpatients were in "hospitals" and 45.8 thousand inpatients were in "general clinics". By sex, 603.8 thousand inpatients were "male" and 715.1 thousand inpatients were "female". By age group, 937.3 thousand inpatients were "65 years or older" and 669.4 thousand inpatients were "75 years or older". Viewing the 7,238.4 thousand of outpatients by type of medical care institution, 1,641.9 thousand patients visited "hospitals", 4,233.0 thousand patients visited "general clinics", and 1,363.4 thousand patients visited "dental clinics". By sex, 3,131.0 thousand patients were "male" and 4,107.3 thousand patients were "female". By age group, 3,510.2 thousand patients were "65 years or older" and 1,895.1 thousand patients were "75 years or older". (Table 1)




Figure 1 Yearly Trend in Estimated Number of Patients by Medical Care Institution

Viewing the yearly trend the number of inpatients in hospitals has been decreasing since 2008, and the number of outpatients had not changed much since 2005(Figure 1, Table 1).




Figure 2 Yearly Trend in Estimated Number of Patients by Age Group

Viewing the yearly trend by age group, the number of inpatients of age group of 0-14, 15-34, 35-64 years old has been decreasing, and 65 years of age or older has been increasing, and the number of outpatients of 65 years of age or older has been increasing (Figure 2).

(2) Estimated number of patients (per day) by Classification of Diseases

Viewing the estimated number of inpatients, the classifications of diseases from the largest to the smallest in estimated number of inpatients are "V Mental and behavioural disorders" (265.5 thousand), "IX Diseases of the circulatory system" (240.1 thousand), "II Neoplasms" (144. 9 thousand).

In estimated number of outpatients by classification of diseases, the classifications of diseases from the largest to the smallest in number of outpatients are "XI Diseases of the digestive system" (1,310.0 thousand), "IX Diseases of the circulatory system" (933.0 thousand), and "XIII Diseases of the musculoskeletal system and connective tissue" (877.8 thousand) (Table 2).

(3) Home medical care

The estimated number of outpatients who received home medical care on the date of survey is 156.4 thousand. By medical care institution, 14.4 thousand patients received home medical care by "hospitals", 101.5 thousand by "general clinics", and 40.6 thousand by "dental clinics".

By type of home medical care in total, 34.0 thousand received "on-call visit", 114.8 thousand received "home visit consultation", and 7.6 thousand received "home visit by person other than physicians or dentists". (Table 3) Viewing the yearly trend, the estimated number of outpatients who received home medical care had not changed much since 2005, but has been increasing since 2008 (Figure 3).



- 2) "On-call visit" means a visit for consultation upon request of residences (including facilities such as "health care facility for the elderly requiring long-term care") of patients.
- 3) "Home visit consultation" means, in medical care, regular home visit by physicians for consultation with patients' consent and planned medical management given to those who are in long-term care and have difficulty in making regular outpatient visit, and in dental care, home visit by dentist to patients' residence (including facilities such as "health care facility for the elderly requiring long-term care") for dental treatment.
- 4) "Home visit by person other than physician/dentist", "Home visit by person other than physician" and "Home visit by person other than dentist" means medical care with patients' consent and planned medical management given to those who are in long-term care and have difficulty in making regular outpatient visit by person other than physician or dentist.

Figure3 Yearly Trend in Estimated Number of Outpatients



(4) Severity

In detail on hospitalization (severity and other circumstances) in percentage, 5.7% is "life-threatening", 74.3% is "small risk of life but requiring inpatient treatment", 13.6% is "to be discharged when acceptance condition is met", and 1.1% is "hospitalization for examination". Patients who are "to be discharged when acceptance condition is met" increase as the age group becomes older. (Figure 4).

- 2) "Small risk of life but requiring inpatient treatment" includes patients scheduled to be discharged.
- 3) "To be discharged when acceptance condition is met" means patients who are not scheduled to be discharged but in condition that can be discharged.
- 4) "Hospitalization for examination" means patients who are hospitalized for examination and includes healthy patients hospitalized for general examination.
- 5) "Others" means patients who are not in the above categories.
- 6) Numbers in () are estimated number of inpatients.
