5 Divorces

(1) Divorces by employment status/occupation of wife and husband before separation

The number of divorces in FY2020 by employment status of husband stood at 161,299 (85.5%) for employed and 15,991 (8.5%) for non-employed.

In addition, the number of divorces by employment status of wife stood at 133,168 (70.6%) for employed and 44,236 (23.4%) for non-employed, and employed wives increased by 7.0 points from 63.6% in the previous survey.

The proportion of divorces by occupation was highest in "Professional and engineering workers" for husbands and in "Service workers" for wives. (Table 15)

(2) Mean age of divorce by employment status/occupation of wife and husband before separation

The average age of divorce (age at separation) by employment status of the husband and wife for divorces who separated and filed for divorce in FY2020 was 41.4 years for employed husbands and 53.8 years for non-employed husbands, and 39.6 years for employed wives and 40.9 years for non-employed wives.

By occupation, it was lowest in "Construction and mining workers" at 39.2 years for husbands and in "Security workers" at 36.6 years for wives, while it was highest in "Administrative and managerial workers" at 47.7 years and at 45.6 years both for husbands and wives, respectively. (Table 16)

(3) Duration of cohabitation before divorce by employment status/occupation of wife and husband before separation

As for the duration of cohabitation (the period from the earlier of the time of the wedding or the they start living together until the end of cohabitation) of divorced couples in FY2020 by employment status, 11.5 years was spent when the husband was "employed" and 18.6 years when the husband was "non-employed," compared to 12.1 years when the wife was "employed" and 12.2 years when the wife was "non-employed".

By occupation, it was shortest in "Construction and mining workers" at 10.7 years for husbands, and in "Security workers" at 8.6 years for wives. (Table 17)



(4) Divorces by the combination of employment status of wife and husband before separation

As for the divorces and the proportion of divorces by the combination of employment status of wife and husband in FY2020, the highest was the combination of "both wife and husband are employed" with 123,586 cases (65.5%), which increased by 7.2 points from the previous survey. The next highest was the combination of "employed husband and non-employed wife" at 19.0%, which decreased by 4.9 points from the previous survey. (5) Divorces by the number of children to whom custody is exercised and by the combination of employment status of wife and husband before separation

As for the number of divorces by the combination of employment status of husband and wife, and by the presence or absence of children (unmarried children under 20 years old; the same below) in custody in FY2020, in cases where both husband and wife were employed, 39.1% of divorces were for "no children in custody" and 60.9% were for "with children in custody". In addition, as for the proportion of divorces where no children to custody, the combination that "husband employed, while wife non-employed" accounts for 41.6%, "husband non-employed, while wife employed" accounts for 56.9%, and "both husband and wife non-employed" accounts for 74.7%. The proportions are higher when husband non-employed. (Table 19)

As for the divorces filed in FY2020 after separation, Age-standardized divorce rates (per 1,000 unmarried population) by the occupation shows that the highest rates were recorded for both husband and wife in "Administrative and managerial workers," at 14.1 for husbands and 15.1 for wives (Table 20).
