Statistics of Imported Foods Monitoring, for FY 2008

The present report summarizes situations of imported foods in FY 2008 such as the number and volume on a declaration basis, number of inspections, and number of violations against the Food Sanitation Law (Law No. 233, 1947, referred to as 'the Law' hereinafter).

1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)

The total number of imported foods (foods, additives, equipment, containers and packages or toys (referred to as 'the food (s)' correctively hereinafter) in FY 2008 was 1,759,123, and was 31,551,097 tons in volume on a declaration.

Inspections were conducted for 193,917 products, accounting for 11.0% of all those declared, consisting of 58,706 administrative inspections (3.3% of all declared products), 140,878 inspections by registered inspection organizations (8.0%: including 95,490 ordered inspections), and 6,208 inspections by foreign official inspection organizations (0.4%).

For 1,150 accounting for 0.1% of all declared products, measures such as reshipment or disposals were taken.

2. Declaration, Inspection and Violation by Quarantine Station (Table 2)

For the number of declarations, the highest was 439,826 in Tokyo (25.0% of all declared products), followed by 252,269 in Narita Airport (14.3%), 226,892 in Osaka (12.9), 190,848 in Yokohama (10.8%), 88,626 in Nagoya (5.0%), 84,664 in Kobe (4.8%), 78,834 in Kawasaki (4.5%), and 63,407 in Kobe Second Section (3.6%).

3. Major Violations against the Food Sanitation Law (Table 3 and Fig. 2)

Total number of violations was 1,150 (gross number: 1,226), consisting of 847 against Article 11 (69.1% of the gross number), 256 against Article 6 (20.9%), 65 against Article 10 (5.3%), 43 against Article 18 (3.5%), 8 against Article 62 (0.7%), and 7 against Article 9 (0.6%), in descending order.

4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)

For the number of declarations by fresh meat (including internal organs), accounts for the highest of all declared products, 162,002 (9.2% of all declared products), followed by beverage including alcohol, 147,226 (8.4%), preparations of vegetables (other than processed mushroom, spices, processed herb and tea), 125,046 (7.1%), tableware, 113,651 (6.5%), fish, 88,210 (5.0%), and Milk and dairy product, 88,095 (5.0%).

Grains have the highest number of violations with 157 (13.6% of the total number of violations), followed by processed aquatic animal product (other than fish and shellfish) 133 (11.6%), cereals 111 (9.7%), Vegetables 80 (7.0%), and Preparations of vegetables (other than processed mushroom, spices, processed herb and tea) 65 (5.7%).

5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)

China accounts for the highest with 473,343 (26.9% of all declared products), followed by the US with 209,145 (11.9%), France, 179,868 (10.2%), Thailand, 128,792 (7.3%), Korea, 110,098 (6.3%), and Italy, 76,921 (4.4%) for the number of declarations by country of origin.

China accounts for the highest with 259 (22.5% of the total number of violations, and 0.05% of all declared products), followed by US with 140 (12.2%), Thailand with 110 (9.6%), Socialist Republic of Viet Nam with 72 (6.3%), and Taiwan with 57 (5.0%) for the number of violations by country of origin.

Figure 1. Changes in Number and Weight of Import Declaration by Year

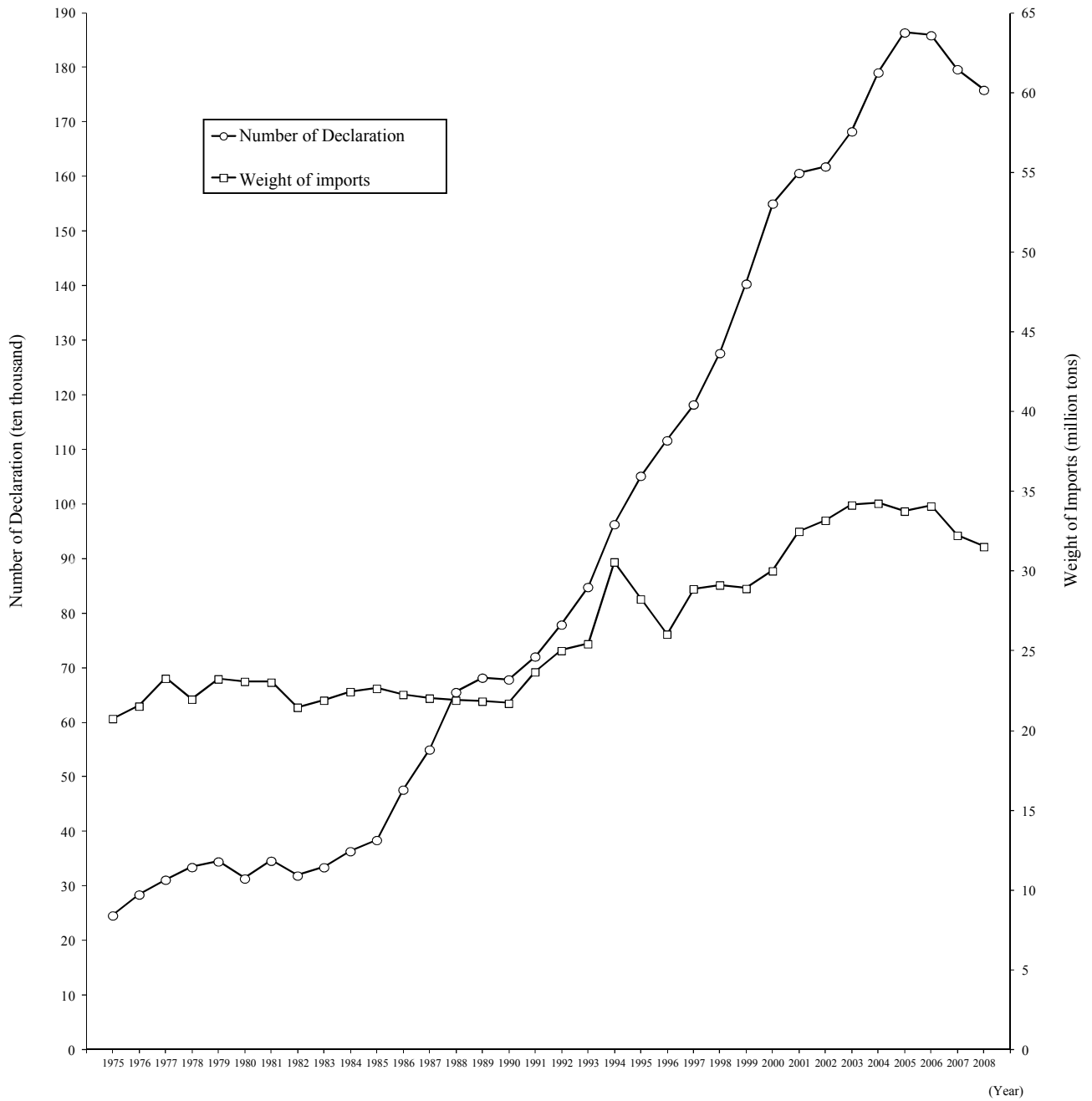
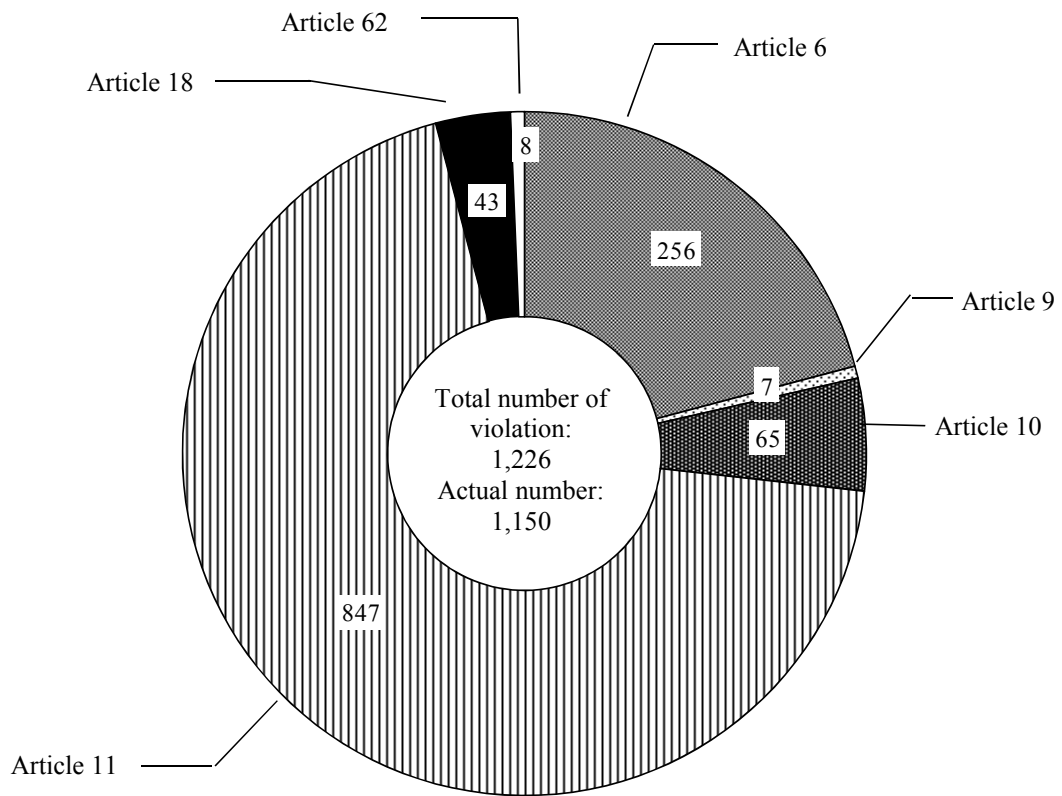

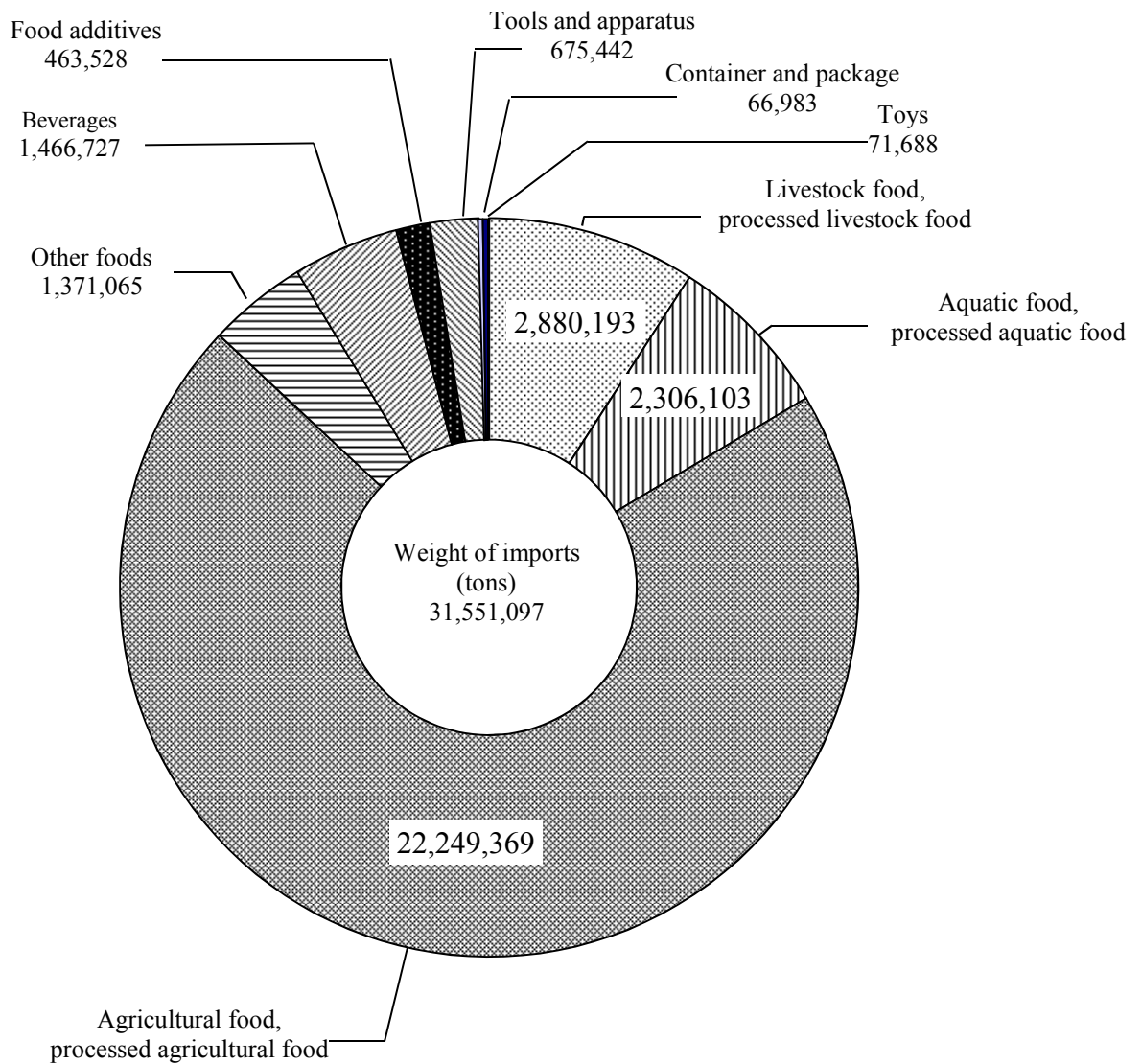
