 In addition to periodic influenza vaccinations for the elderly implemented by municipalities, a novel influenza (A/H1N1) vaccination program has been implemented by the government (since October 2010)

- Securing a supply of vaccines and therapeutic drugs
- Promotion of preventive measures against infection at facilities
