Statistics of Imported Foods Monitoring for FY 2015

The present report summarizes situations of imported foods in FY 2015 such as the number and weight on a declaration basis, number of inspections, and number of violations against the Food Sanitation Act (Act No.233, 1947, referred to as ‘the Act’ hereinafter).

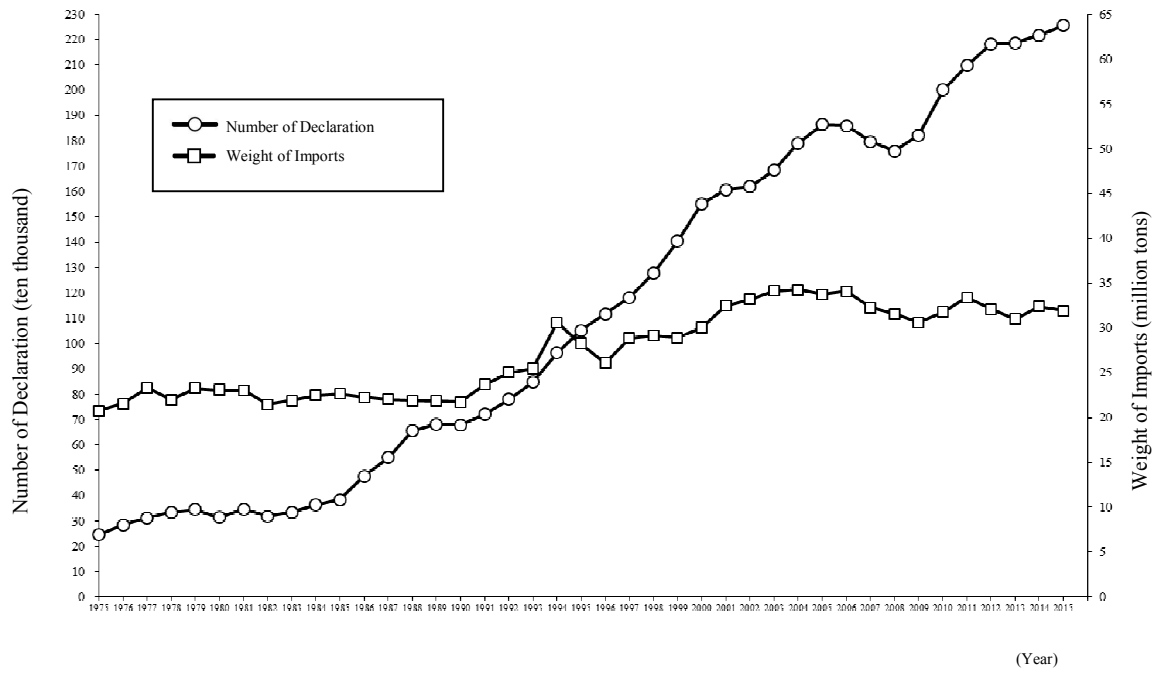


Figure 1. Changes in Number and Weight of Import Declaration by Year (Note 1)

1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)

The total number of imported foods (foods, additives, equipment, containers and packaging or toys (referred to as ‘the food (s)’ correctively hereinafter) in FY 2015 was 2,255,019, and was 31,900,083 tons in weight on a declaration.

Inspections were conducted for 195,667 products, accounting for 8.7% of all those declared, consisting of 56,466 administrative inspections (2.5% of all declared products), 151,672 inspections by registered inspection organizations (6.7%: including 58,874 ordered inspections), and 4,195 inspections by foreign official laboratories (0.2%).

For 858 accounting for 0.04% of all declared products, measures such as reshipment, disposals, or diversion to non-food use were taken.

2. Declaration, Inspection and Violation by Quarantine Station (Table 2)

For the number of declarations, the highest was 602,881 in Tokyo (26.7% of all declared products), followed by 286,168 in Narita Airport (12.7%), 275,545 in Osaka (12.2%), 214,023 in Yokohama (9.5%), 138,044 in Kawasaki (6.1%), 122,908 in Nagoya (5.5%), 108,802 in Kobe (4.8%), and 79,787 in Fukuoka (3.5%).

3. Major Violations against the Food Sanitation Act (Table 3 and Fig. 2)

Total number of violations was 858, consisting of 541 against Article 11 (63.1% of the total number), 243 against Article 6 (28.3%), 42 against Article 10 (4.9%), 31 against Article 18 (3.6%), 1 against Article 9 (0.1%), and 1 against Article 62 (0.1%), in descending order.

4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)

For the number of declarations by product, tableware accounts for the highest, 224,521 (10.0% of all declared products), followed by alcoholic beverages, 209,282 (9.3%), fresh meat (including internal organs), 175,493 (7.8%), other tools and apparatus, 168,314 (7.5%), preparations of vegetables (other than processed mushroom, spices, processed herb and tea), 155,165 (6.9%), and processed fish product, 105,908 (4.7%).

Nuts and seeds have the highest number of violations with 139 (16.2% of the total number of violations), followed by processed aquatic animal product (other than fish and shellfish) 74 (8.6%), processed fish product 67 (7.8%), Cereals 65 (7.6%), and Pulses 51 (5.9%).

Composition of weight of imports by classification of items is shown in Figure 3.

5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)

For the number of declarations by country (including regions), the highest was 710,676 for China (31.5% of all declared products), followed by 224,318 for the US (9.9%), 206,455 for France (9.2%), 156,937 for Thailand (7.0%), 119,685 for Korea (5.3%), and 111,441 for Italy (4.9%).

For the number of violations, the highest was 170 for China (19.8% of the total number of violations), followed by 76 for US (8.9%), 70 for Thailand (8.2%), 68 for Viet Nam (7.9%), 35 for Korea (4.1%), and 35 for Italy (4.1%).

Composition of weight of imports by regions is shown in Figure 4.

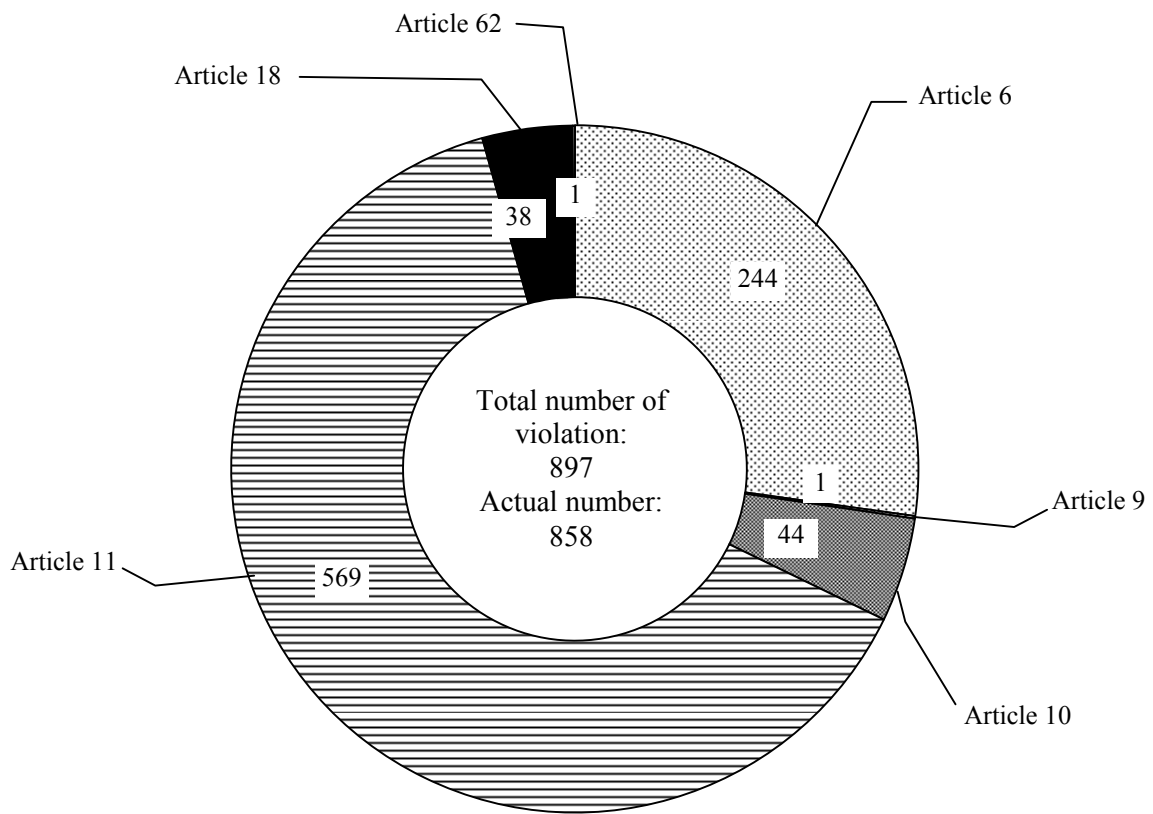



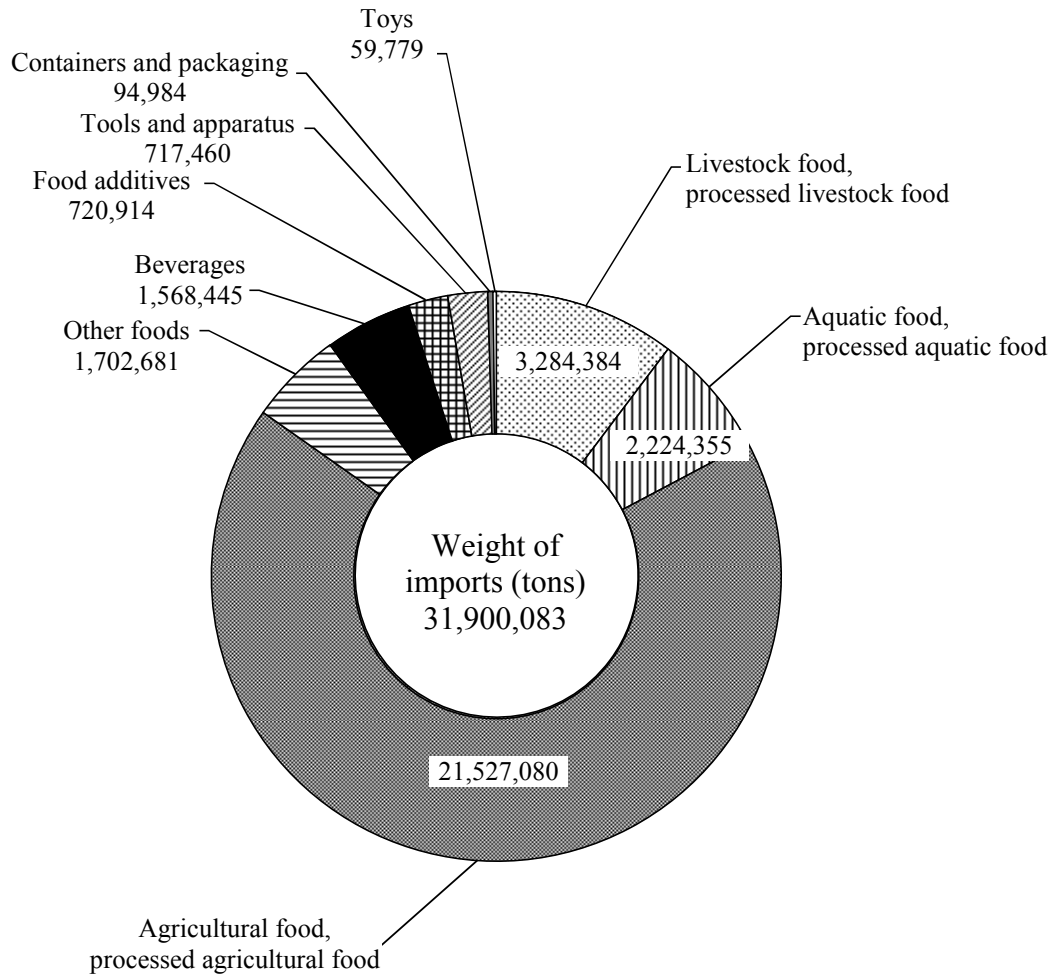
