1. APEC Forum on HRD 2013

The Ministry of Health, Labour and Welfare, Japan with collaboration with JAVADA (Japan Vocational Ability Development Association), held APEC Forum on Human Resources Development 2013 from November 20th to 22nd 2013 in Nara city, Japan. Prof. Tatehito (Ken) Shimoda skillfully coordinated the seventeenth forum under the theme: Human Resources Development for People with Disabilities "Improvement of Employability". The forum was supported by Mr. Akimichi Mikami (Director General of National Vocational Rehabilitation Center for Persons with Disabilities) from Japan as a keynote speaker, and Ms. Carina Dea Klein (Labor Officer from the U.S. Department of State), Mr. Bum-Gyu Kim (Researcher from Korea Employment Agency for the Disabled) and Ms. Lisbeth Kelly (Branch Manager from Department of Social Services, Australia) as resource persons. Other APEC economies (Malaysia, Papua New Guinea, the Philippines, Chinese Taipei, Thailand and Viet Nam) also attended the forum and presented their reports. Furthermore, Dr. YougHwan Kim, the lead shepherd of APEC Human Resources Development Working Group, attended the opening session and made his speech.

The participants exchanged information on their measures and experiences concerning improvement of employability of people with disabilities (hereafter "PWDs") through presentations and group discussions. During the forum, they also visited Nara Prefecture Advanced Vocational Training School to observe a sales training course for people with intellectual disabilities.

In the wrap –up, Prof. Shimoda commented about what were learned in the forum. He pointed out that the weight/priorities of policies/challenges can change according to economies and stages of development, and continuous support is necessary throughout all stages of life.

3. ASEAN Vocational Training Instructor's Manual Seminar

The Ministry of Health, Labour and Welfare, Japan and Malaysia's CIAST (Centre for Instructor and Advanced Skill Training) in collaboration with JAVADA held ASEAN Vocational Training Instructor's Manual (hereinafter referred to as "GAIN": Guide for ASEAN Vocational Training Instructors) Seminar from December 2nd to 13th 2013 in Shah Alam, Malaysia for the first time as three years project.

The goal of this seminar is to disseminate GAIN to vocational training (hereinafter "VT") instructors and to contribute to the improvement of the administration and evaluation of VT in the ASEAN countries (Cambodia, Indonesia, Laos, Myanmar, Malaysia, the Philippines, Thailand and Vietnam). Main contents of the last December's seminar were "The purpose of VT and Role of VT concerned personnel" and "Evaluation of VT".


A Japanese expert, Mr. Atsunori Kume, a member of GAIN Development Committee, conducted a 10 days seminar based on GAIN for 10 VT concerned personnel (one participant from each country; Cambodia, Laos, Myanmar, the Philippines, and Vietnam, two participants from Malaysia and three participants from Thailand). Also one Malaysian counterpart personnel assisted this seminar.

The seminar was comprised of three parts; lecture, group discussion and presentation in each GAIN item. Additionally, the participants visited two sites; CIAST and Akademi Binaan Malaysia. During the seminar, the participants learned a lot in line with GAIN contents. In particular, the practice of VT improvement cycle: PDCA (Plan-Do-Check-Action), POCE (Purpose-Objectives-Contents-Evaluation) and 5 levels of VT evaluation got good reviews.

At the end of the seminar, all participants made presentations of their action plans and they are expected to disseminate the point of GAIN in their countries based on the action plans.

For the next step, new contents will be added into GAIN and hopefully the improved GAIN will be disseminated more widely.
