Statistics of Imported Foods Monitoring for FY 2018

The present report summarizes situations of imported foods in FY 2018 such as the number and weight on a declaration basis, number of inspections, and number of violations against the Food Sanitation Act (Act No.233, 1947, referred to as ‘the Act’ hereinafter).

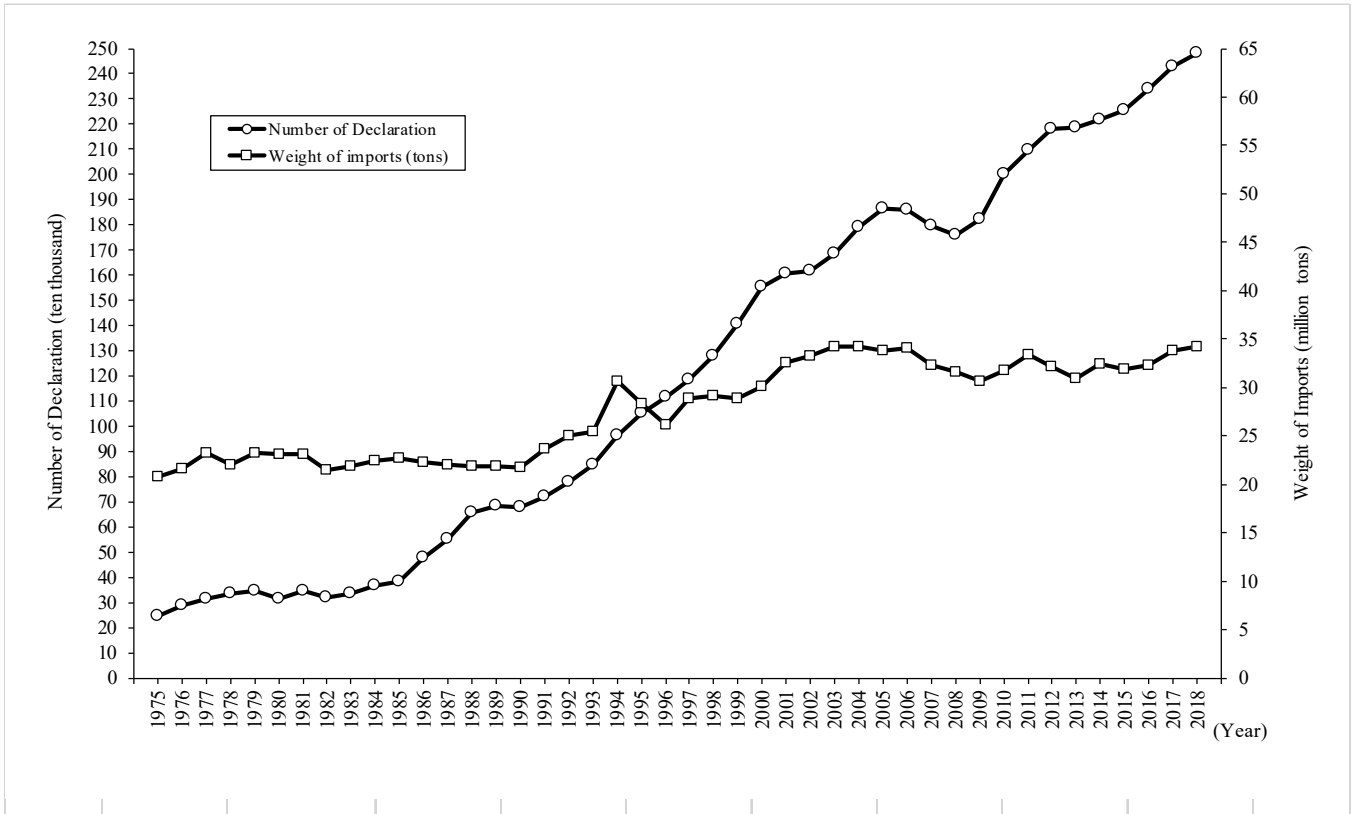


Figure 1. Changes in Number and Weight of Import Declaration by Year (Note 1)

1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)

The total number of imported foods (foods, additives, equipment, containers and packaging or toys for infants (referred to as ‘the food (s)’ correctively hereinafter) in FY 2018 was 2,482,623, and was 34,172,567 tons in weight on a declaration.

Inspections were conducted for 206,594 products, accounting for 8.3% of all those declared, consisting of 69,409 administrative inspections (2.8% of all declared products), 153,833 inspections by registered inspection organizations (6.2%: including 60,373 ordered inspections), and 4,524 inspections by foreign official laboratories (0.2%).

For 780 accounting for 0.03% of all declared products, measures such as reshipment, disposals, or diversion to non-food use were taken.

Trends in annual import declaration are shown in Figure 1.

2. Declaration, Inspection and Violation by Quarantine Station (Table 2)

For the number of declarations, the highest was 668,864 in Tokyo (26.9% of all declared products), followed by 309,846 in Osaka (12.5%), 269,406 in Narita Airport (10.9%), 243,444 in Yokohama (9.8%), 150,167 in Kawasaki (6.0%), 147,880 in Nagoya (6.0%), 110,627 in Kobe (4.5%), and 92,760 in Fukuoka (3.7%).

3. Major Violations against the Food Sanitation Act (Table 3 and Fig. 2)

For the number of violations by articles (total; 780), the highest was 480 against Article 11 (61.5%), followed by 229 against Article 6 (29.4%), 36 against Article 18 (4.6%), 30 against Article 10 (3.8%), 4 against Article 9 (0.5%), and 1 against Article 62 (0.1%).

4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)

For the number of declarations by product, tableware accounts for the highest, 257,790 (10.4% of all declared products), followed by alcoholic beverages, 220,749 (8.9%), other tools and apparatus, 212,091 (8.5%), fresh meat (including internal organs), 208,954 (8.4%), preparations of vegetables (other than processed mushroom, spices, processed herb and tea), 174,207 (7.0%), and processed fish product, 119,672 (4.8%).

Nuts and seeds have the highest number of violations with 109 (14.0% of the total number of violations), followed by processed aquatic animal product (other than fish and shellfish) and cereals, both with 54 (6.9%), processed fish products with 53 (6.8%), preparations of vegetables (other than processed mushroom product, spices, processed herb, and tea) with 51 (6.5%).

Composition of weight of imports by classification of items is shown in Figure 3.

5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)

For the number of declarations by country (including regions), the highest was 825,249 for China (33.2% of all declared products), followed by 226,483 for the US (9.1%), 212,095 for France (8.5%), 166,680 for Thailand (6.7%), 123,290 for Korea (5.0%), and 118,984 for Italy (4.8%).

For the number of violations, the highest was 179 for China (22.9% of the total number of violations), followed by 133 for the US (17.1%), 53 for Thailand (6.8%), 52 for Viet Nam (6.7%), 32 for France (4.1%) and 29 for Italy (3.7%).

Composition of weight of imports by regions is shown in Figure 4.

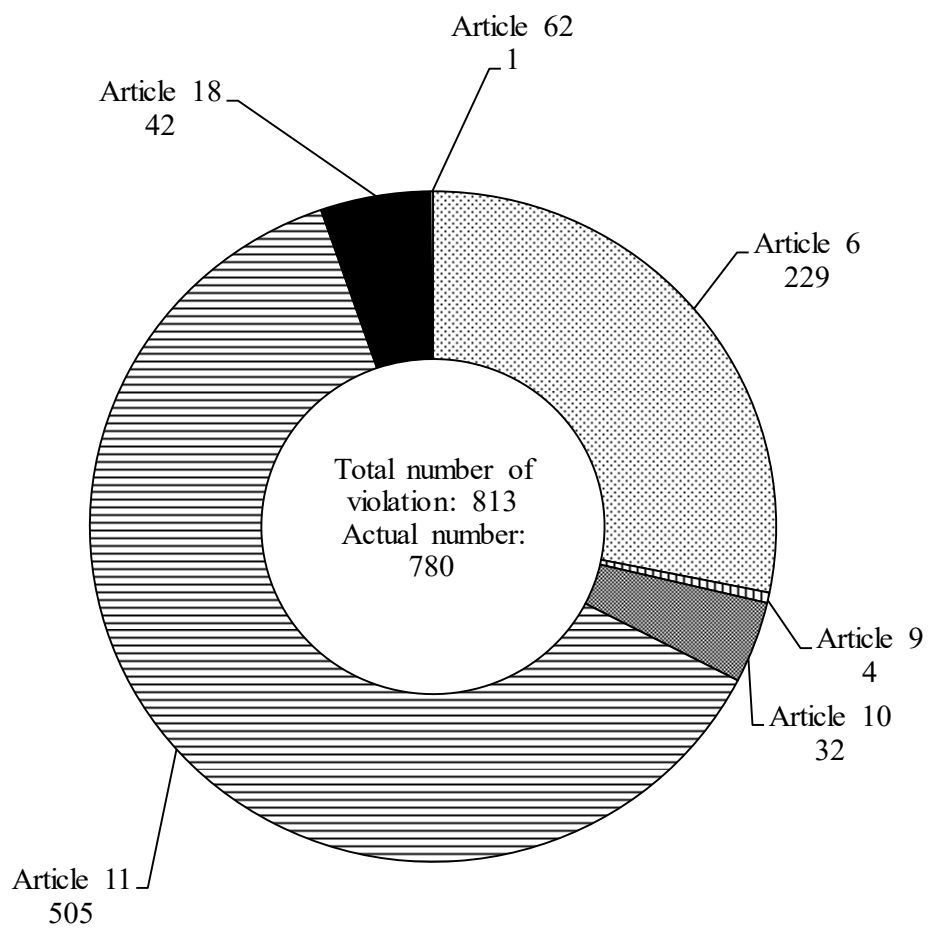

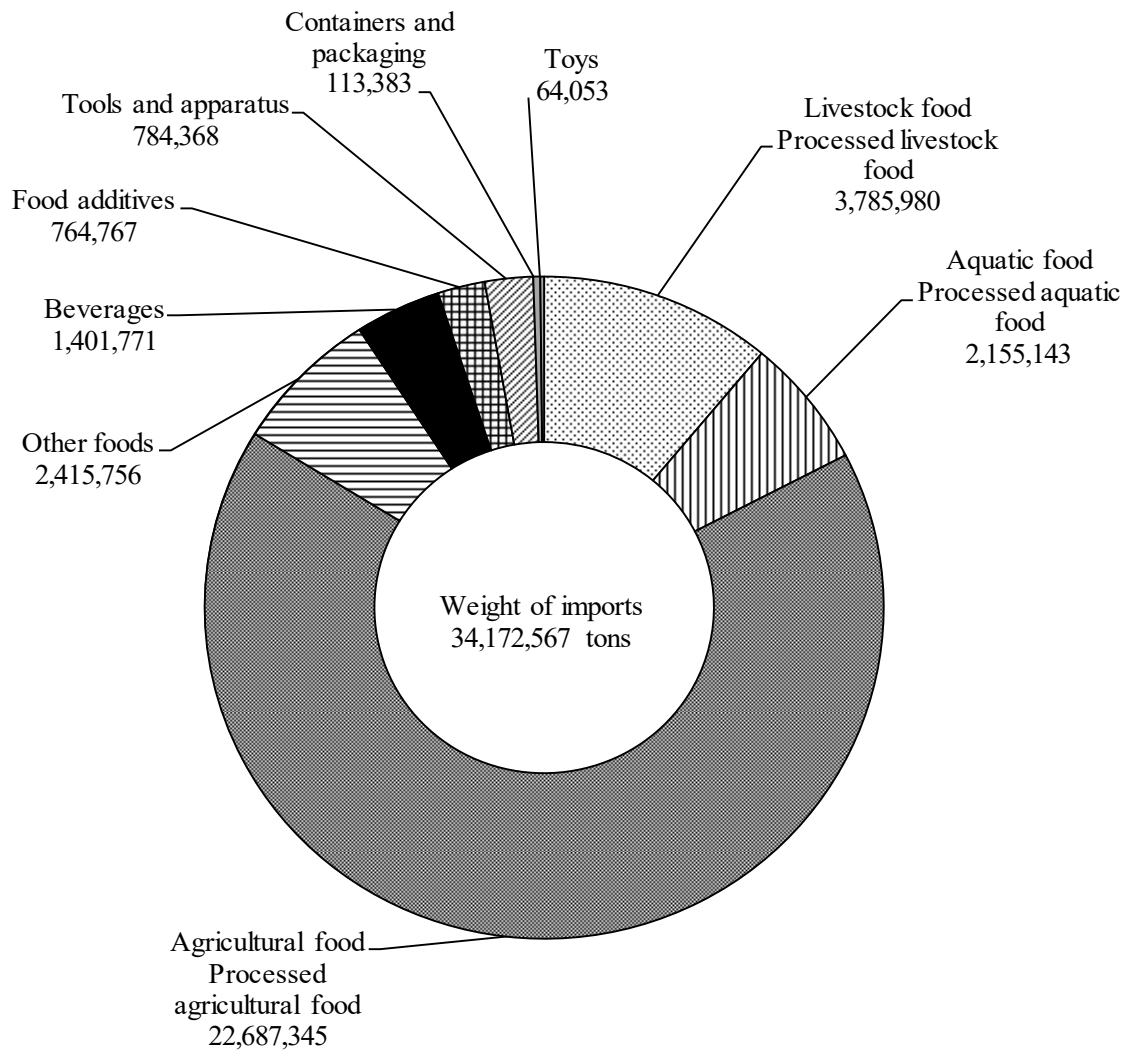

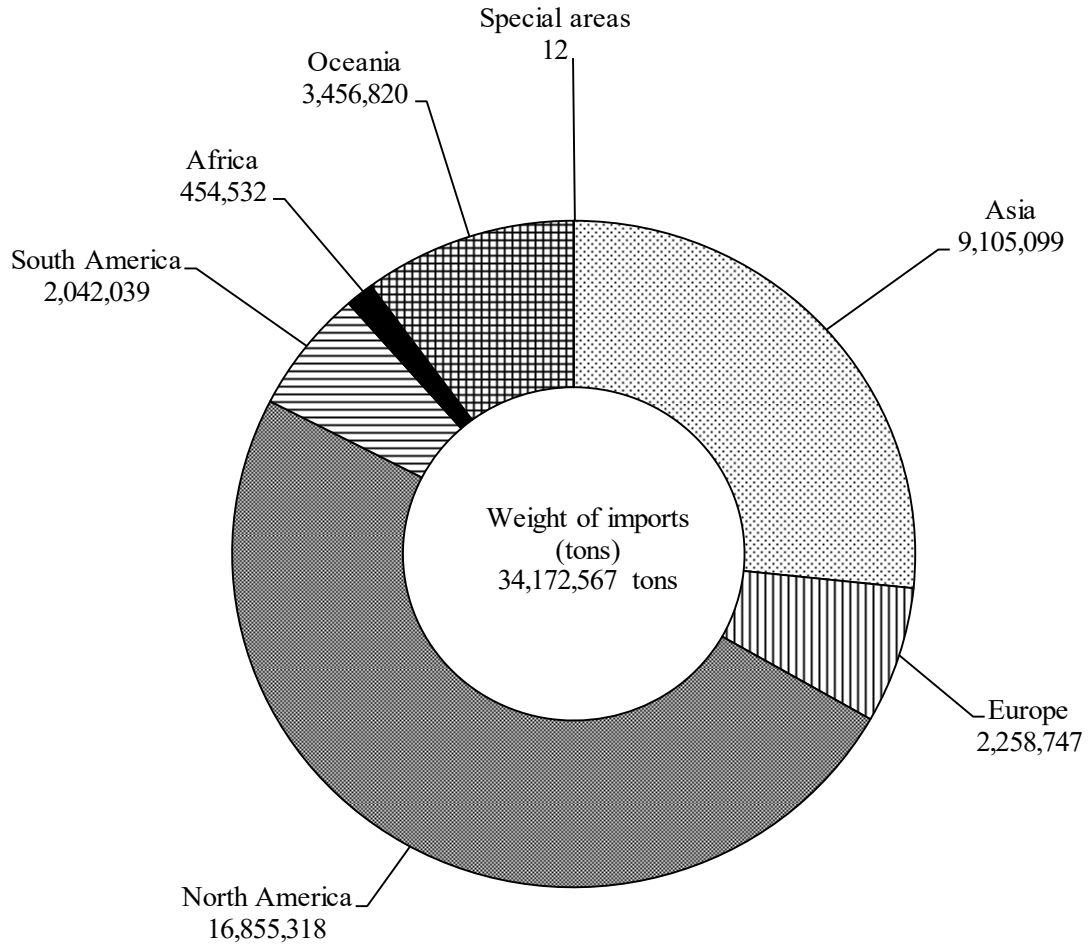
