Statistics of Imported Foods Monitoring for FY 2019

The number of declarations, imported weight, and inspections of imported foods in the year under review (FY 2019) and the number of inspections under the Food Sanitation Act (Act No. 233 of 1947; hereinafter referred to as "the Law".) The number of violations, etc. is as follows.

1. Declarations, inspections, and violations by year (Table 1, Figure 1)

The total number of imported foods (foods, additives, equipment, containers and packaging or toys for infants (referred to as 'the food (s)' collectively hereinafter) in FY 2019 was 2,544,674, and was 33,272,955 tons in weight on a declaration.

Inspections were conducted for 217,216 products, accounting for 8.5% of all those declared, consisting of 69,483 administrative inspections (2.7% of all declared products), 168,799 inspections by registered inspection organizations (6.6%: including 69,185 ordered inspections), and 4,414 inspections by foreign official laboratories (0.2%).

For 763 accounting for 0.03% of all declared products, measures such as reshipment, disposals, or diversion to non-food use were taken.

Change in quantities of imports and declarations by year are shown in Figure 1.

2. Declarations, inspections, and violations by quarantine station (Table 2)

For the number of declarations, the highest was 681,942 in Tokyo (26.8% of all declared products), followed by 312,888 in Osaka (12.3%), 270,860 in Narita Airport (10.6%), 262,671 in Yokohama (10.3%), 154,786 in Kawasaki (6.1%), 150,943 in Nagoya (5.9%), 101,750 in Fukuoka (4.0%), and 100,201 in Kobe (3.9%).

3. Major examples of violations of the Food Sanitation Act (Table 3, Figure 2)

For the number of violations of the Law by articles (total; 763)*, the highest was 450 against Article 13 (59.0%), followed by 222 against Article 6 (29.1%), 53 against Article 12 (6.9%), 35 against Article 18 (4.6%), 3 against Article 62 (0.4%), and 1 against Article 10 (0.1%).

One violation out of 763 violations was a violation of Articles 12 and 13.

The breakdown of the number of violations of the Food Sanitation Act by article is shown in Figure 2.

4. Declarations, Inspections, and Violations by Product (Table 4, Figure 3)

For the number of declarations by product, tableware accounts for the highest, 269,125 (10.6% of all declared products), followed by alcoholic beverages, 232,707 (9.1%), other tools and apparatus, 228,869 (9.0%), fresh meat (including edible offal), 215,329 (8.5%), preparations of vegetables (other than processed mushrooms, spices, processed herb and tea), 176,623 (6.9%), and processed fish product, 121,395 (4.8%).

Cereals have the highest number of violations with 88 (11.5% of the total number of violations), followed by nuts and seeds with 59 (7.7%), aquatic animal products (other than fish and shellfish) with 54 (7.1%), confectionery (excluding frozen foods) with 51 (6.7%), preparations of vegetables (other than processed mushroom products, spices, processed herb, and tea) with 49 (6.4%).

Composition of weight of imports by classification of items is shown in Figure 3.

5. Declarations, Inspections, and Violations by Country of Origin (Table 5, Figure 4)

For the number of declarations by country (including regions), the highest was 842,228 for China (33.1% of all declared products), followed by 225,458 for the US (8.9%), 218,430 for France (8.6%), 168,450 for Thailand (6.6%), 127,188 for Korea (5.0%), and 124,259 for Italy (4.9%).

For the number of violations, the highest was 185 for China (24.2% of the total number of violations), followed by 136 for the US (17.8%), 58 for Viet Nam (7.6%), 45 for India (5.9%) and 37 for Thailand and Taiwan (4.8%).

Composition of weight of imports by regions is shown in Figure 4.

(In this statistical section, the article of the Law after the revision by the Law to partially amend the Food Sanitation Act, etc. [Act No. 46 of 2018] is described.)






