


Overview of JICA's Work for Healthy and Active Ageing





Priority Cooperation Topics

- Building a system that allows people to live in a familiar community until the end of their lives (community-based integrated care)

- Frailty prevention and extension of healthy life expectancy

Collaboration between multiple professions and other organizations




[Background]
