- Japanese : Shakai Hoken Roumu Shi (Sharoushi)
- English : Labor and Social Security Attorney
- Legal specialist based on the Sharoushi Act of 1968
- Number of Shaorushi : 42,000 in Japan (2022)



#### 2. Services of Shaorushi

- Preparation and submission of documents designated by labor and social security related laws
- Bookkeeping designated by labor and social security related laws
- HR consultation and advisory services
- Payroll calculation
- Act as assessor in the court with general lawyers
- Act as a proxy on individual labor mediation for either party and also take the role of mediator at the resolution processes of individual labor disputes.
