### 輸入生食用かきの取扱いについて

食品衛生法等の一部を改正する法律（平成 30 年法律第 46 号。以下「改正法」という。）による改正後の食品衛生法（昭和 22 年法律第 233 号。以下「法」という。）第 11 条第 2 項の施行に伴い、食品衛生法等の一部を改正する法律の施行に伴う厚生労働省関係省令の整備に関する省令（令和元年厚生労働省令第 68 号。以下「改正省令」という。）が公布され、平成 30 年 6 月 28 日付け生食発 0628 第 1 号及び令和元年 11 月 7 日付け生食発 1107 第 3 号により、改正法及び改正省令の内容等について連絡しているところです。

法第 11 条第 2 項及び改正省令による改正後の食品衛生法施行規則（昭和 23 年厚生省令第 23 号。以下「施行規則」という。）第 11 条の 2 第 2 項により、輸入される生食用かきについては、輸出国の政府機関によって発行された証明書（以下「衛生証明書」という。）又はその写しを添付したものでなければ、これを販売の用に供するために輸入してはならないこととなりました。

当該規定については、食品衛生法等の一部を改正する法律の施行期日を定める政令（令和元年政令第 121 号）により、本年 6 月 1 日に施行されることから、本年 6 月 1 日以降に輸入される生食用かきの取扱いを下記のとおりとしますので、御了知の上、その運用に遺漏のないようお願いいたします。

## 2 その他
