

Common items: Construction sites general The important points for Safety and health

(1) The education at the time of recruitment, the sending-off education, and the newcomer education.

The Occupational Safety and Health Act stipulates that employers should provide various health and safety education. You can get education you need.

1. Education at the Time of Employment:

When employing a worker, conduct the safety and health education on the work to be engaged.

2. Training for newcomers:

The training for newcomers includes site conditions, work outlines, hazardous locations, and site rules. (After checking the work experience, state of health, etc. of the person, the information is used as a reference for appropriate arrangement.)

* In addition to the above, employers provide safety training and other sending-off education before sending workers to construction sites. Furthermore, in order to carry out dangerous works such as operating a mobile crane, it is necessary to obtain a license stipulated by the law and to take the skill training course and the special education.



(3) Appropriate clothing


The first step in safety is to wear properly!



^{*} As a rule, the personal fall arrest systems should be a full harness type, but if the height is 5m or less, a "waist belt type" can be used.


[Appropriate protective equipment]

It is stipulated that the necessary protective equipment should be worn according to the work, and that the personal protective equipment is properly worn to protect yourself.



(4) Safety rules in a construction site

These activities are prohibited!




Matters to fallow


- Be sure to use safety passages.
- Do not enter the operating radius of heavy machines.
- Do not approach material storage places carelessly.
- Use the designated lifting equipment when moving to work places on a second floor or higher.
- Rest places must be designated locations and time zones.
- Work contents must be strictly followed the instructions given by a foreman or a supervisor.

(5) The STCC Activity (Sorting-Tidy- Clean-Cleanliness)

STCC: Sorting, Tidy, Clean, Cleanliness

The basis of safety is tidy. At a construction site, a stumbling and falling accidents are endless, but if things are tidy and put in order, or there are no stumbling blocks, stumbling accidents can be eliminated.






- Let's clean up after the work.


(6) Safe construction cycle

(7) The risk prediction activity at a work place



By visiting the place where the work is going to be carried out, discuss "Dangers in the work at the place on that day, and what kind of attention should be payed when working here." by all members involved.

1. Think about potential danger if you work here under the given directions.

(Examples)

- Are there any openings easy to fall into on the work floor?
- Are there any places possible to contact with machines?
- Are you instructed different work than usual?
- 2. Tell anything you thought to a person in charge.
- 3. If you do not satisfy an instruction from a person in charge of the work, confirm it until you understand.
