## **Outline of the Survey**

# The 5th Longitudinal Survey of Adults in the 21st Century (2012 Cohort)

#### 1 Objective

The Longitudinal Survey of Adults in the 21st Century (2012 Cohort) has been conducted since 2012 in order to capture information instrumental for the planning, formation and implementation of necessary MHLW measures such as measures for combating Japan's declining birth rate through the continuous observation of the actual situations and changes over years of the marriage, childbirth, work and other conditions of the males and females surveyed. The latest is the 5th survey.

#### 2 Survey coverage and survey objects

The survey objects were selected from males and females aged 20 to 29 as of the end of October 2012 nationwide (excluding some regions of Fukushima prefecture) who participated in the 3rd or 4th survey (and their spouses (limited to those identified as such by the time when the 1st survey was conducted)).

#### 3 Date of the survey

Survey cycle:Once a year (1st Wednesday of November)Date of the 5th survey:Wednesday, November 2, 2016

#### 4 Questionnaire types

(1) Male questionnaire (2) Female questionnaire

#### 5 Survey Items

- Male questionnaire:.....Labour force status, work pattern, marriage status, the number of children, the desired number of children, willingness to have a child(ren), child view, etc.

- (2) Female questionnaire: ..... Labour force status, work pattern, marriage status, the number of children, the desired number of children, willingness to have a child(ren), child view, etc.

#### 6 Survey method

Each surveyed individual filled out a questionnaire mailed by the Ministry of Health, Labour and Welfare, and then submitted it to the Ministry of Health, Labour and Welfare by mail. On-line responses using the Internet have been permitted since the 5th survey.

# **Definition of terms**

- 1 **"Husband and wife"** or **"Married"** also includes those who are living in a real marital relationship but have yet to submit their marriage registration.
- 2 **"Single"** or **"Single person"** refers to any person who responded "Have no spouse" and there is no distinction between unmarried, separated and bereaved statutes. It also includes those who responded "Have a child(ren)".
- 3 **"Willingness to have a child(ren)"** is related to the question "How do you feel about having a child(ren) in the future?", which was posed to those who responded that the "Desired number of children" was 1 or more.
- 4 **"Status of child-care leave system, etc."** is related to the question asking whether their place of work has any child-care leave system that is available in their own work pattern.

5 "Child-care leave system", "Short working hour system" and "Reduced working hours for child-rearing, etc." refer to the following systems. Child-care leave system: ...... A system that allows workers to take leave to rear their child(ren) Short working hour system: ..... A system that shortens prescribed normal working hours Reduced working hours for child-rearing, etc.: .... Reduced working hours for child-rearing outside the "child-care leave system" and "short working hour system" (e.g. flextime system, earlier/later work start/finish times,

exemption from unprescribed working hours

(overtime), etc.

- 6 "Desired number of children" means how many children the respondent wants to have in total.
- 7 "Child view" is related to the question asking what the respondent thinks about having a child(ren).
- 8 "1st survey" and "5th survey" refer to the items identified in each survey.
- 9 "In the last 4 years" refers to the period from the 1st survey to the 5th survey.
