

Sum up of radionuclide test results reported in FY2025
(Up-to-date Report as of 31 December 2025)

- Food products and wild harvests are monitored by prefectural governments based on the Japanese maximum levels of radiocesium set by the Ministry of Health, Labour and Welfare.
 - The monitoring plans are annually revised, focusing on the items with higher concentration.
 - Monitoring of radionuclides in food are mainly carried out before shipment.
 - Most of the data exceeding the levels are derived from areas where restrictions of distribution have been instructed.
 - Appropriate measures are taken for individual pre-sales / recall cases. The items are disposed of and shipments are suspended based on Food
- ※The shipment to the domestic market of the beef was successfully suspended since it was detected through pre-shipment monitoring test.
As a result of the investigation, the cow was unintentionally fed old rice straw exposed in spring 2011 when FDNPP accident had occurred.
All feedlot farmers are individually instructed in the isolation measure that old rice straw shall never be fed.
