

Sum up of radionuclide test results reported in FY2023
(Up-to-date Report as of 31 March 2024)

- Food products and wild harvests are monitored by prefectural governments based on the Japanese maximum levels of radio-caesium set by the Ministry of Health, Labour and Welfare.
 - The monitoring plans are annually revised, focusing on the items with higher concentration.
 - Monitoring of radionuclides in food are mainly carried out before shipment.
 - Most of the data exceeding the levels are derived from areas where restrictions of distribution have been instructed.
 - Appropriate measures are taken for individual pre-sales / recall cases. The items are disposed of and shipments are suspended based on Food Sanitation Act.
- *This case was attributed to cross-contamination from an appliance used for preparation during post-harvest.
