## **Statistics of Imported Foods Monitoring, for FY 2013**

The present report summarizes situations of imported foods in FY 2013 such as the number and volume on a declaration basis, number of inspections, and number of violations against the Food Sanitation Law (Law No.233, 1947, referred to as ‘the Law’ hereinafter).

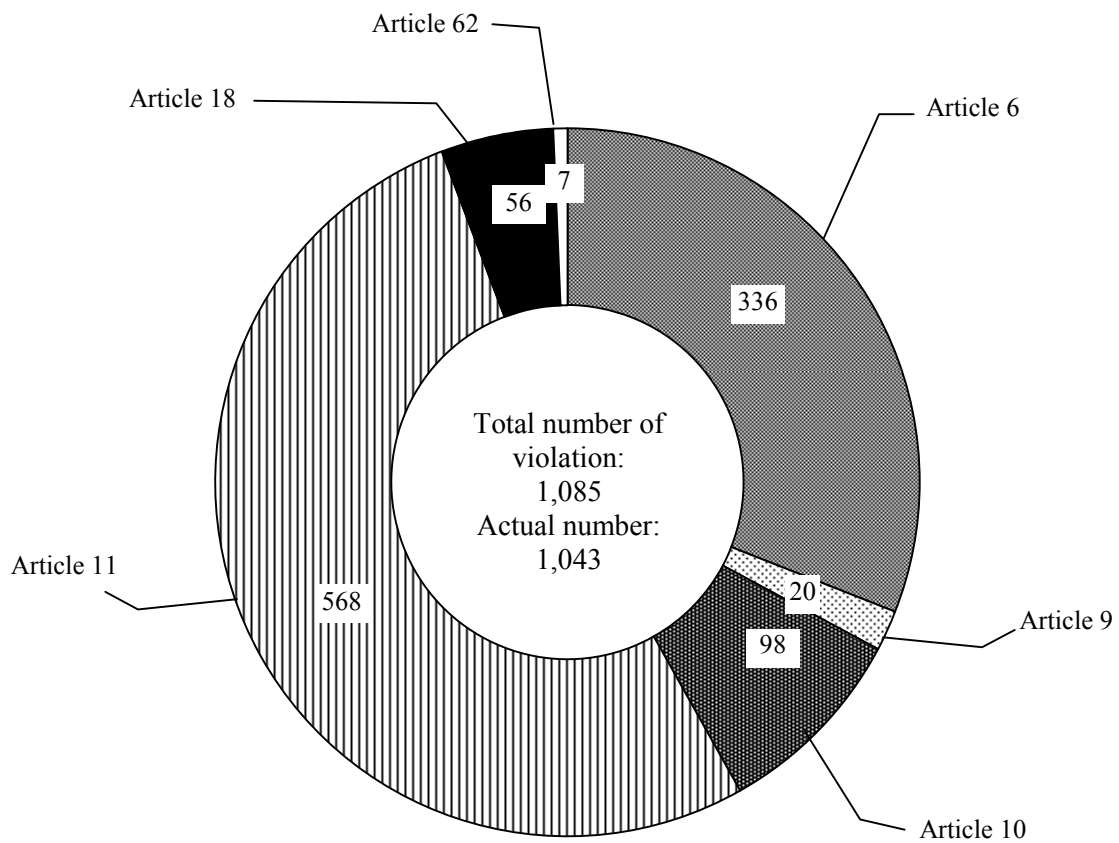
Figure 1. Changes in Number and Weight of Import Declaration by Year (Note 1)

### **1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)**

The total number of imported foods (foods, additives, equipment, containers and packages or toys (referred to as ‘the food (s)’ correctively hereinafter) in FY 2013 was 2,185,480, and was 30,982,370 tons in volume on a declaration.

Inspections were conducted for 201,198 products, accounting for 9.2% of all those declared, consisting of 60,599 administrative inspections (2.8% of all declared products), 147,852 inspections by registered inspection organizations (6.8%: including 59,543 ordered inspections), and 4,493 inspections by foreign official laboratories (0.2%).

For 1,043 accounting for 0.05% of all declared products, measures such as reshipment, disposals, or diversion to non-food use were taken.

### **2. Declaration, Inspection and Violation by Quarantine Station (Table 2)**

For the number of declarations, the highest was 598,811 in Tokyo (27.4% of all declared products), followed by 288,735 in Narita Airport (13.2%), 275,392 in Osaka (12.6%), 204,180 in Yokohama (9.3%), 118,506 in Kawasaki (5.4%), 116,598 in Nagoya (5.3%), 100,868 (4.6%) in Kobe, and 78,720 in Fukuoka (3.6%).

### **3. Major Violations against the Food Sanitation Law (Table 3 and Fig. 2)**

Total number of violations was 1,043 (gross number: 1,085), consisting of 568 against Article 11 (52.4% of the gross number), 336 against Article 6 (31.0%), 98 against Article 10 (9.0%), 56 against Article 18 (5.2%), 20 against Article 9 (1.8%), and 7 against Article 62 (0.6%), in descending order.

#### **4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)**

For the number of declarations by product, beverage including alcohol accounts for the highest, 193,382 (8.8% of all declared products), followed by tableware, 193,180 (8.8%), fresh meat (including internal organs), 169,102 (7.7%), preparations of vegetables (other than processed mushroom, spices, processed herb and tea), 161,356 (7.4%), other tools and apparatus, 140,178 (6.4%), and processed fish product, 100,321 (4.6%).

Cereals have the highest number of violations with 156 (15.0% of the total number of violations), followed by processed aquatic animal product (other than fish and shellfish) 84 (8.1%), processed fish product 70 (6.7%), seeds and nuts 66 (6.3%), and preparations of vegetables (other than processed mushroom, spices, processed herb and tea) 62 (5.9%).

#### **5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)**

China accounts for the highest with 676,475 (31.0% of all declared products), followed by the US with 241,522 (11.1%), France, 206,054 (9.4%), Thailand, 144,870 (6.6%), Korea, 130,562 (6.0%), and Italy, 103,860 (4.8%) for the number of declarations by country of origin.

China accounts for the highest with 244 (23.4% of the total number of violations), followed by US with 196 (18.8%), Thailand with 74 (7.1%), Viet Nam with 69 (6.6%), and Italy with 52 (5.0%) for the number of violations by country of origin.



