## The summary of Measures against novel influenza

In order to summarize the countermeasures taken by the Ministry of Health, Labour and Welfare for the current outbreak of novel influenza (A/H1N1) and to best use this (summary) in revision of response to future resurgence of novel influenza (A/H1N1) and countermeasure for outbreak of avian influenza (H5N1), we established Summary Meeting for measures against novel influenza (A/H1N1) (hereinafter referred to as "Summary Meeting") under Headquarters for measures against novel influenza of the Ministry of Health, Labour and Welfare on 31 March 2001 and have conducted consideration.

In Summary Meeting, we have conducted consideration in regard to future tasks, especially shoreline measure, public health measure, surveillance, public relation system, medical care system, vaccine etc. based on hearing of opinions etc. of committed on-site persons and experts of respective sectors. Summary Meeting was held seven times since 31 March 2010 with report being summarized on 10 June of the same year (Chart 1-7-1).

Hereafter, based on the contents of suggestion by Summary Meeting as well as in cooperation with Cabinet Secretariat and related ministries and agencies, we shall conduct revision of Action Plan for Measures against novel influenza and Guidelines etc. providing against resurgence of the current novel influenza (A/H1N1) and outbreak of avian influenza (H5N1), thereby best use this (summary) in strengthening future organizational framework.
