Statistics of Imported Foods Monitoring, for FY 2011

The present report summarizes situations of imported foods in FY 2011 such as the number and volume on a declaration basis, number of inspections, and number of violations against the Food Sanitation Law (Law No.233, 1947, referred to as ‘the Law’ hereinafter).

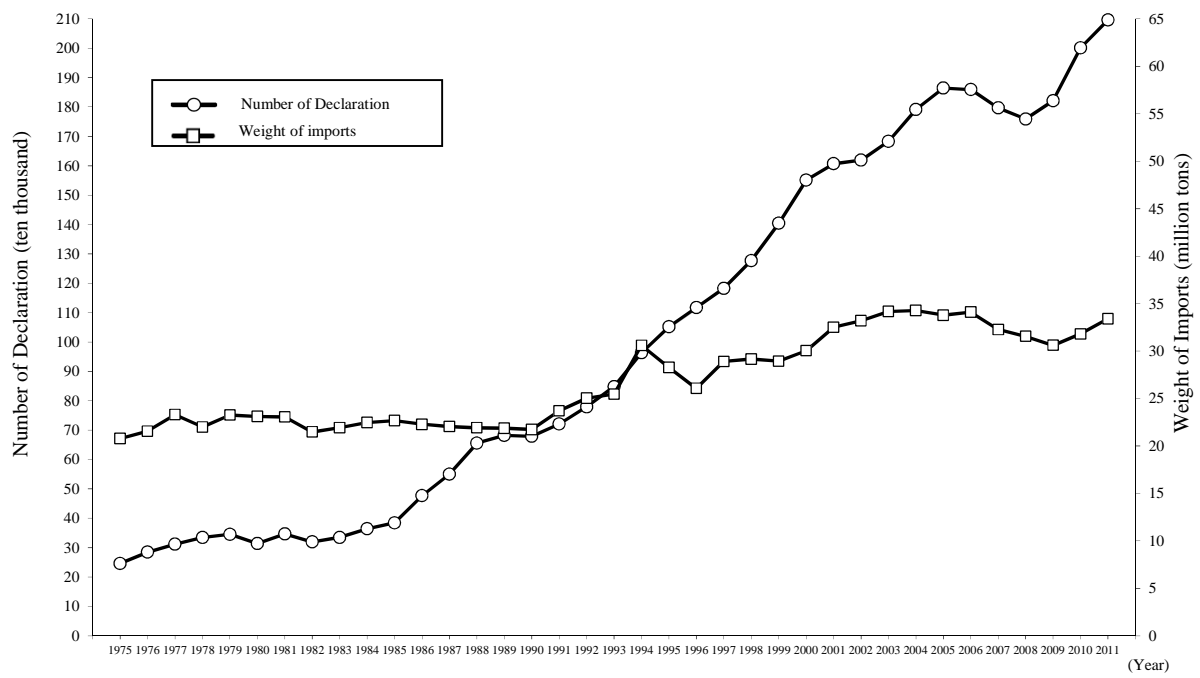
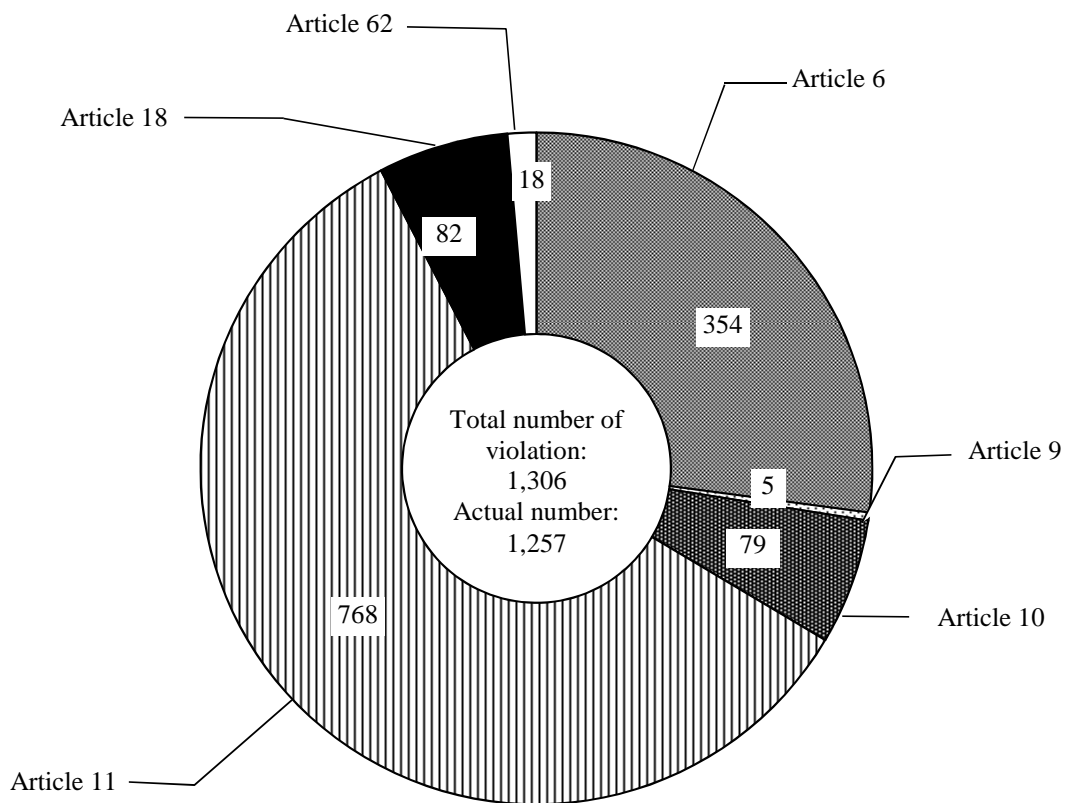


Figure 1. Changes in Number and Weight of Import Declaration by Year

1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)

The total number of imported foods (foods, additives, equipment, containers and packages or toys (referred to as ‘the food (s)’ correctively hereinafter) in FY 2011 was 2,096,127, and was 33,407,240 tons in volume on a declaration.

Inspections were conducted for 231,776 products, accounting for 11.1% of all those declared, consisting of 58,941 administrative inspections (2.8% of all declared products), 180,023 inspections by registered inspection organizations (8.6%: including 99,117 ordered inspections), and 5,546 inspections by foreign official inspection organizations (0.3%).

For 1,257 accounting for 0.1% of all declared products, measures such as reshipment or disposals were taken.

2. Declaration, Inspection and Violation by Quarantine Station (Table 2)

For the number of declarations, the highest was 572,347 in Tokyo (27.3% of all declared products), followed by 279,660 in Osaka (13.3%), 277,203 in Narita Airport (13.2%), 195,426 in Yokohama (9.3%), 109,363 in Nagoya (5.2%), 101,530 in Kobe (4.8%), 96,935 in Kawasaki (4.6%), and 71,349 in Kobe Second Section (3.4%).

3. Major Violations against the Food Sanitation Law (Table 3 and Fig. 2)

Total number of violations was 1,257 (gross number: 1,306), consisting of 768 against Article 11 (58.8% of the gross number), 354 against Article 6 (27.1%), 82 against Article 18 (6.3%), 79 against Article 10 (6.0%), 18 against Article 62 (1.4%), and 5 against Article 9 (0.4%), in descending order.

4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)

For the number of declarations by beverage including alcohol, accounts for the highest of all declared products, 174,782 (8.3%), followed by fresh meat (including internal organs) 161,944 (7.7% of all declared products), preparations of vegetables (other than processed mushroom, spices, processed herb and tea), 155,863 (7.4%), tableware, 150,753 (7.2%), other tools and apparatus, 117,904 (5.6%), and processed fish product, 96,616 (4.6%).

Processed aquatic animal product (other than fish and shellfish) has the highest number of violations with 184 (14.6% of the total number of violations), followed by cereals 167 (13.3%), grains 105 (8.4%), preparations of vegetables (other than processed mushroom, spices, processed herb and tea) 80 (6.4%), and pulses 64 (5.1%).

5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)

China accounts for the highest with 633,733 (30.2% of all declared products), followed by the US with 228,505 (10.9%), France, 195,729 (9.3%), Thailand, 152,299 (7.3%), Korea, 147,473 (7.0%), and Italy, 93,757 (4.5%) for the number of declarations by country of origin.

China accounts for the highest with 278 (22.1% of the total number of violations), followed by US with 174 (13.8%), Socialist Republic of Viet Nam with 166 (13.2%), Thailand with 93 (7.4%), and Italy with 50 (4.0%) for the number of violations by country of origin.

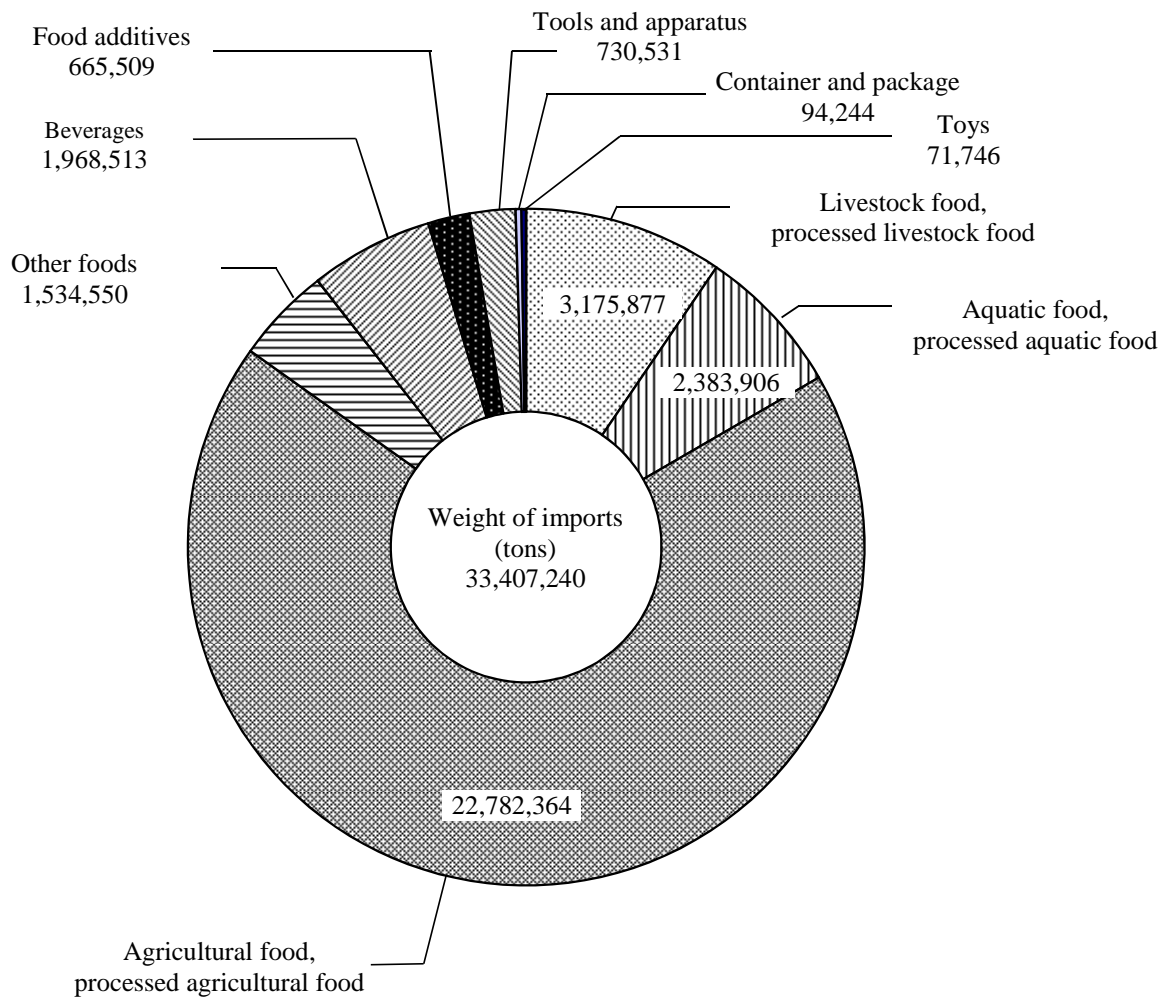

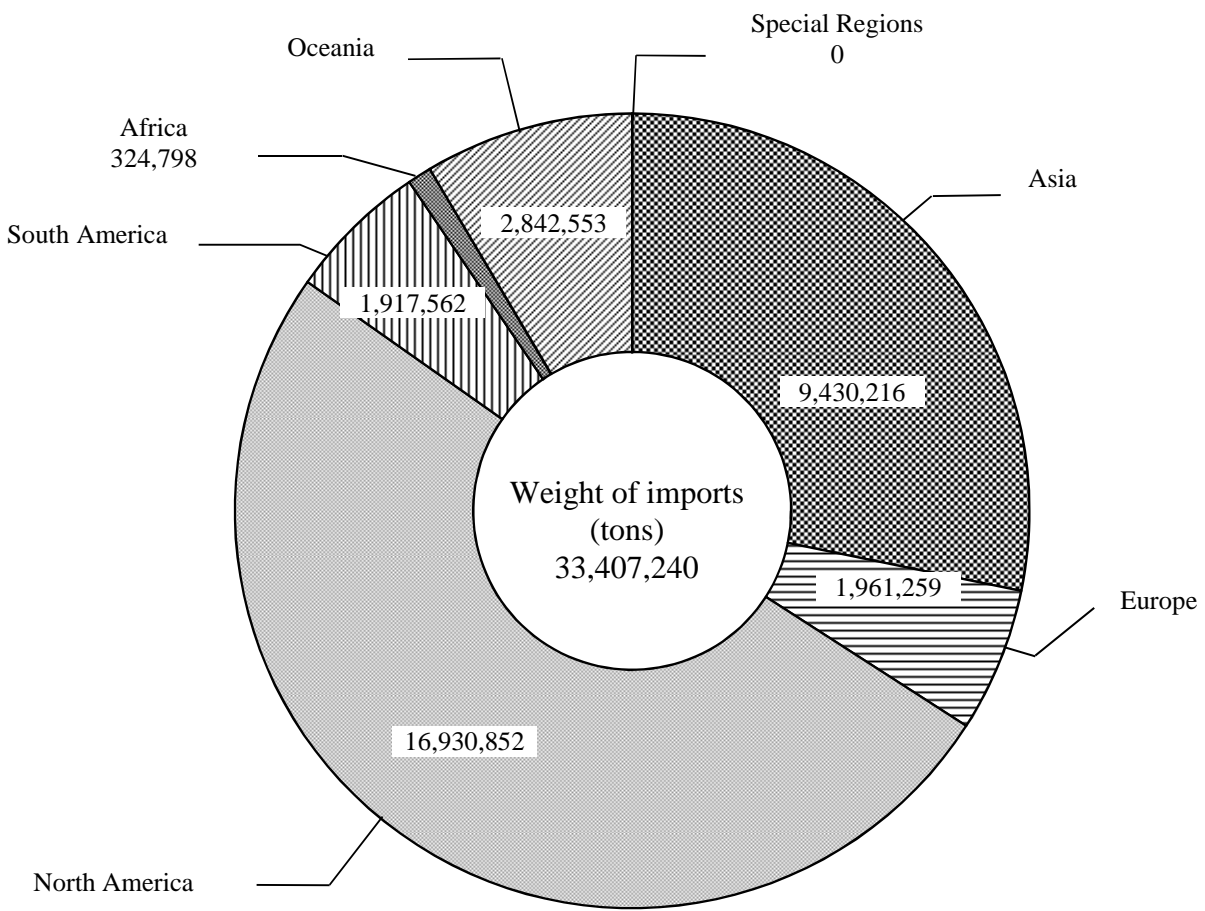


