Statistics of Imported Foods Monitoring, for 2007

The present report summarizes situations of imported foods in 2007 such as the number and volume on a declaration basis, number of inspections, and number of violations against the Food Sanitation Law (Law No.233, 1947, referred to as ‘the Law’ hereinafter).

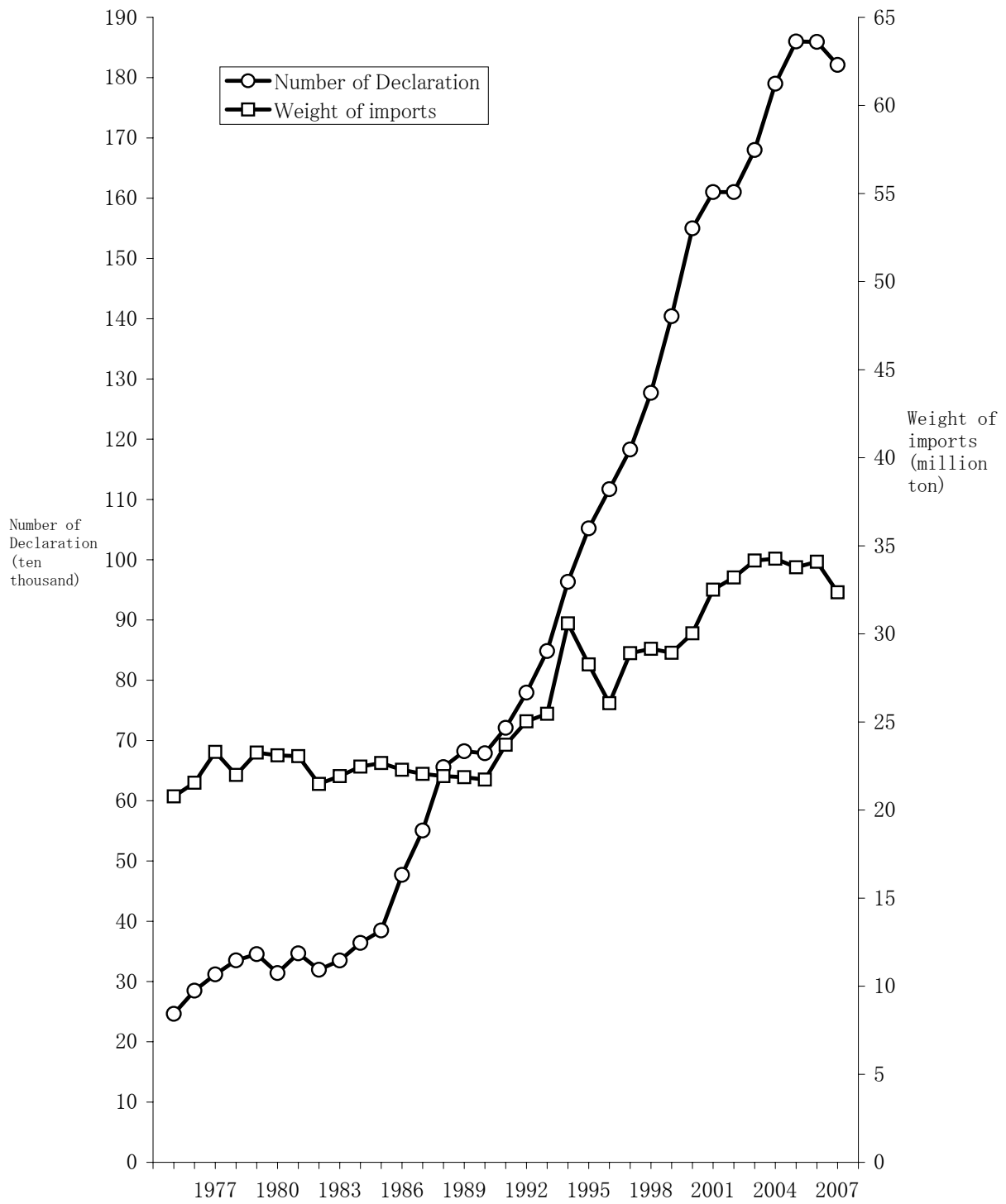
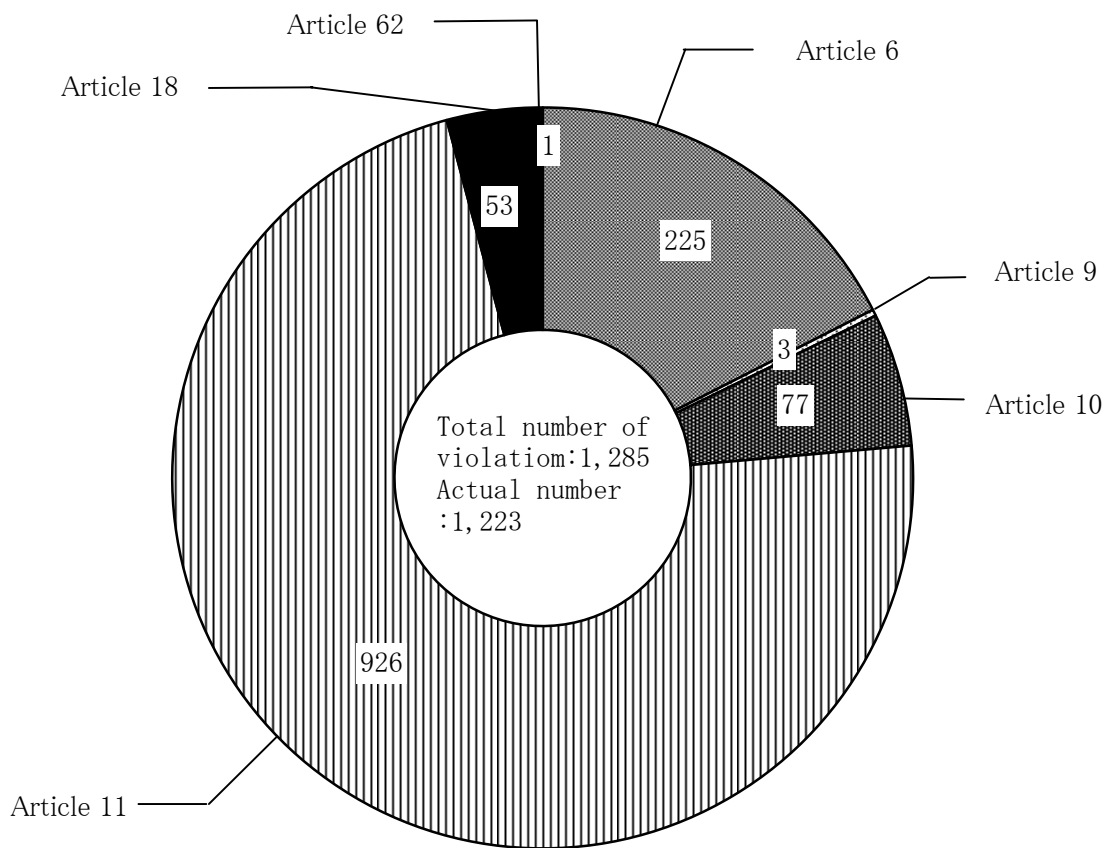


Figure 1. Change in Number and Weight of Import Declaration by Year

1. Declaration, Inspection and Violation by Year (Table 1 and Fig. 1)

The total number of imported foods (foods, additives, equipment, containers and packages) was 1,821,172, and was 32,358,26 tons in volume on a declaration basis, 2 % lower and 5 % lower than the previous year respectively.

Inspections were conducted for 204,578 products, accounting for 11.2 % of all those declared, consisting of 58,027 administrative inspections (3.2 % of all declared products), 150,760 inspections by registered inspection organizations (8.3%: including 98,977 ordered inspections), and 5,674 inspections by foreign official inspection organizations (0.3%).

For 1,223 accounting for 0.1% of all declared products, measures such as reshipment or disposals were taken.

2. Declaration, Inspection and Violation by Quarantine Station (Table 2)

For the number of declarations, the highest was 437,422 in Tokyo (24.0% of all declared products), followed by 270,100 in Narita Airport (4.9%), 217,721 in Osaka (12.0%), 197,707 in Yokohama (10.9%), 89,950 in Nagoya (4.9%), 89,441 in Kobe (4.9%), 86,395 in Kawasaki (4.7%), and 65,725 in Kobe Second Section (3.6%).

3. Major Violations Against the Food Sanitation Law (Table 3 and Fig. 2)

Total number of violations was 1,223 (gross number: 1,285), consisting of 926 against Article 11 (72.1% of the gross number), 225 against Article 6 (17.5%), 77 against Article 10 (6.0%), 53 against Article 18 (4.1%), 3 against Article 9 (0.2%), and 1 against Article 62 (0.1%), in descending order.

4. Declaration, Inspection and Violation by Product (Table 4 and Fig. 3)

For the number of declarations by beverage including alcohol, accounts for the highest, 156,015 (8.6 % of all declared products), followed by product, processed vegetables (excluding processed mushroom, spices, processed herb and tea) accounts for the highest, 150,907 (8.3% of all declared products), fresh meat (including internal organs) 149,898 (8.2%), Tableware, 101,484 (5.6%). and milk and milk product, 94,371 (5.2%).

processed marine product (excluding fish and shellfish) has the highest number of violations with 211 (17.3% of the number of violations), followed by Cereal, 114 (9.3%), grains, 97 (7.9%) and product, processed vegetables (excluding processed mushroom, spices, processed herb and tea), 86 (7.0%).

5. Declaration, Inspection and Violation by Country of Origin (Table 5 and Fig. 4)

China accounts for the highest with 563,847 (31.0% of all declared products), followed by the US with 197,507 (10.8%), France, 196,566 (10.8%), Thailand, 116,867 (6.4%), Korea, 89,704 (4.9%), and Itaria, 77,647 (4.9%) for the number of declarations by country of origin. China accounts for the highest with 409 (33.4% of the number of violations), followed by Vietnam with 150 (12.3%), U.S with 126 (10.3%) Thailand with 106 (8.7%), and Ecuador with 60 (4.7%) for the number of violations by country of origin.

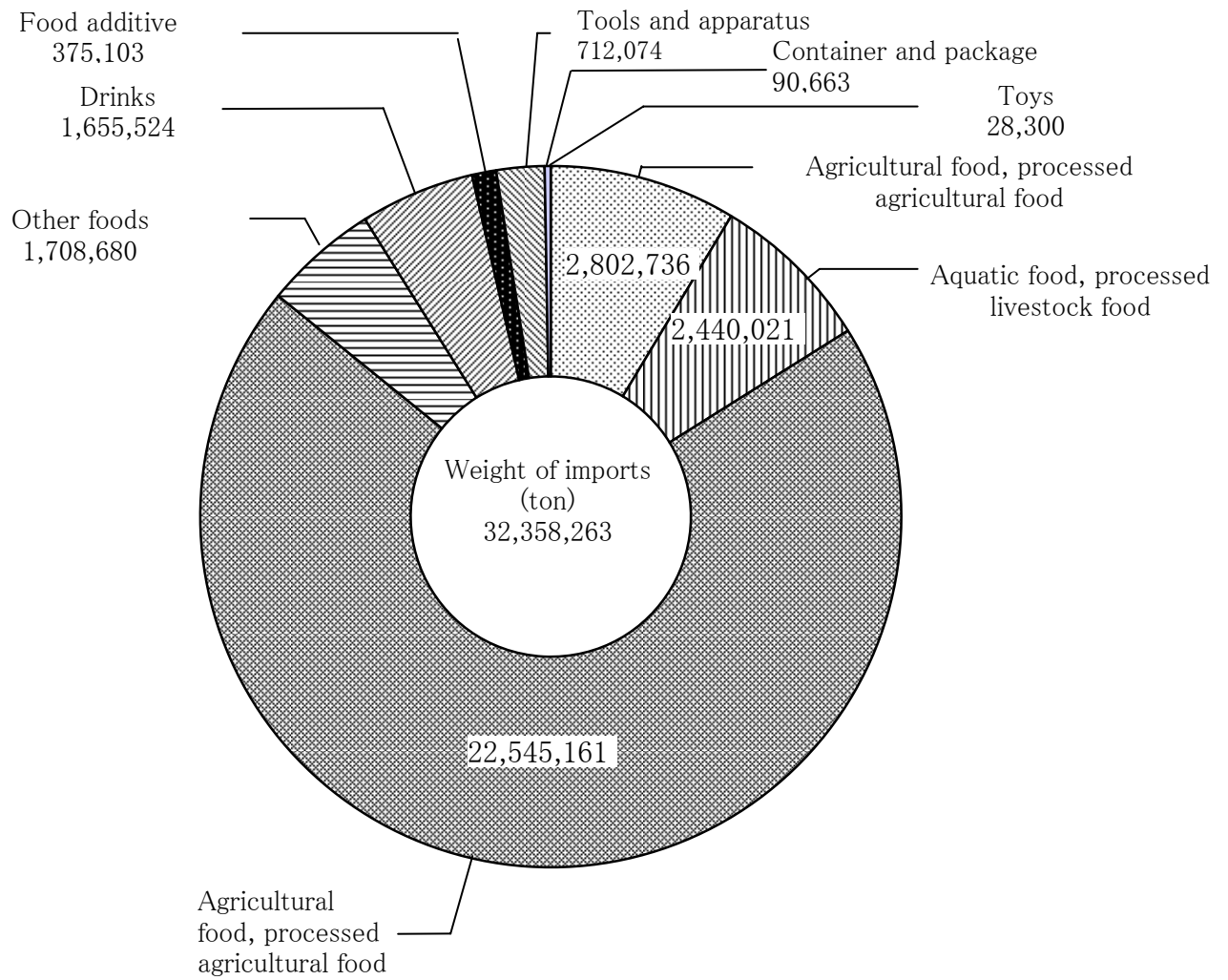

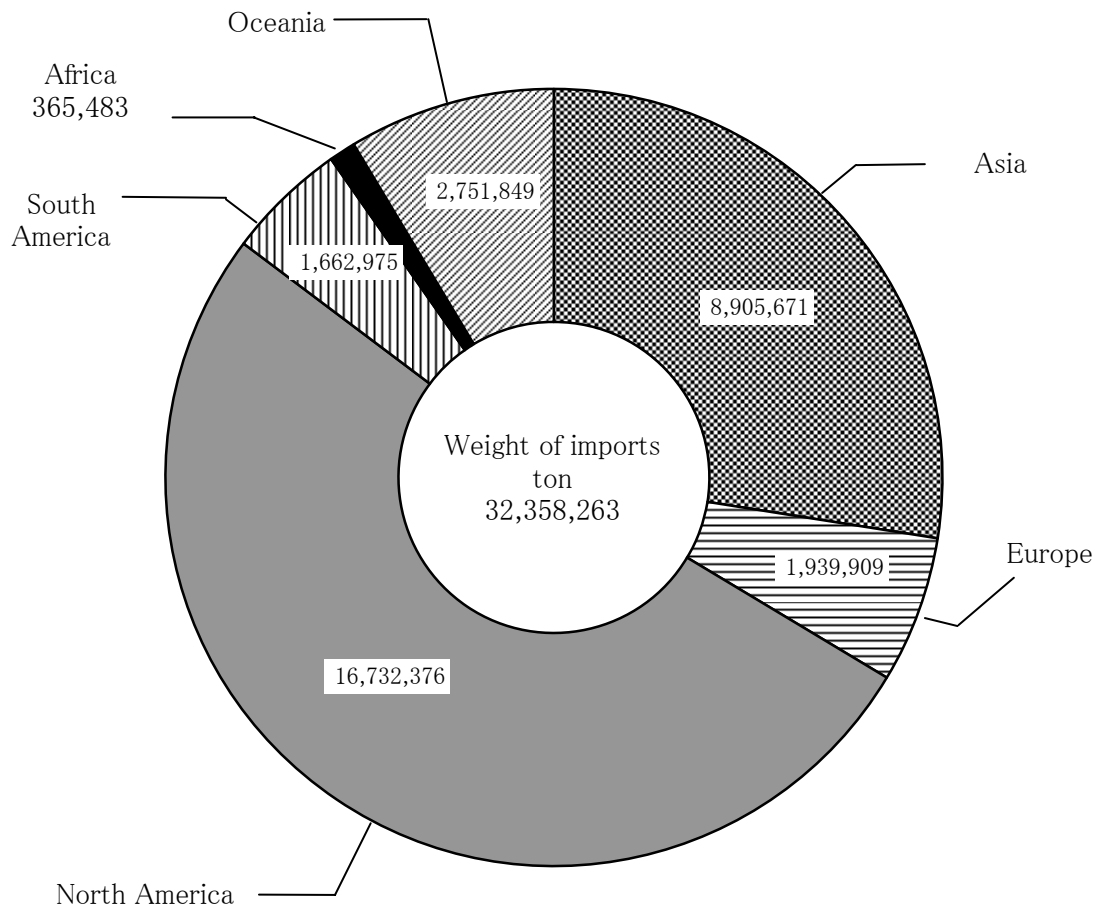
