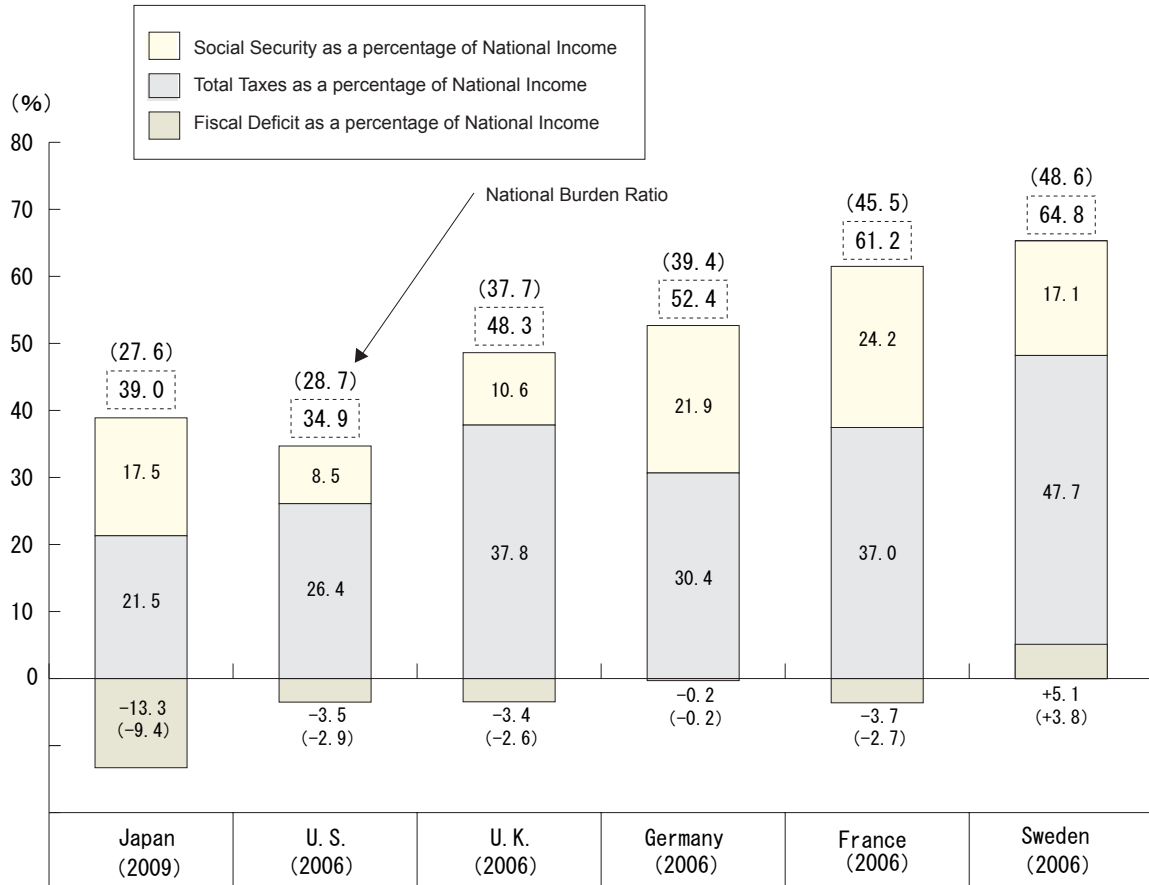


International Comparison of National Burden Ratio
